## Five seek four school board slots

### Newcomers are among the candidates

Colby Free Press Three incumbents and two newcomers are on the Tuesday ballot for four positions on the Golden Plains School Board.

The only contested race is between current board member Mark Miller and newcomer David Gould. Jay Todd, also a newcomer to elective office, is running uncontested for position 2, with incumbent Kathy Albers not seeking another term. Incumbents LeRoy Spresser and Paul Bruggeman will be on the ballots for positions 3 and 7 respectively, and will not have opposition.

• Miller, 40, is a married farmer and rancher. He and his wife Lori have three children, Josh, Abbie and Jesse. He has served for three years on the board and is a graduate of

Golden Plains High School. "I have enjoyed being on the board," he said. "and I feel the community needs to help out with the school and the kids' education...I want to make sure it stays on the

right track." Miller said he also feels his experience on the board will be a benefit.

"It takes one or two years on the board to understand how everything works in areas like the budget, which is one of the hardest things facing our small schools."

## Four want school board seats

Free Press Editor One incumbent and three newcomers are seeking the four positions open on the Colby Board of Education in the Tuesday, April, 1

Stan Molstad has served on the board for the past six years, filling the unexpired term of Larry Sloan and then being elected to a full four-

The other three candidates — Dewey Augustine, Joel Powell and Kevan Taylor — all said this is their first time running for public office. The other three board members -Bill Miller, Wilburn Holloway and Kathy Gordon — who are currently serving on the board decided not to seek re-election for various reasons.

In talking with the four candidates, each gave varying views on why they chose to run. For Molstad, 41, he said he believes his experience will be a big help. He said he has been through building projects during his tenure on the board and with another project possible, his previous experience would be help-

Molstad said he has lived in Colby all his life, having graduated from Colby High School and major-

ing in business at Colby Community College. He is a partner at Colby Canvas. Molstad and his wife, Maradith, have two children, Katie, 18, and Erica, 16, both attending Colby High School.

Augustine, 48, said he thinks he has a positive attitude about the school district to include the administration, teachers, coaches and students. He also said that having children in the school district and following their activities and academics, he is confident he can be an asset to the board. He and his wife, Pam, have two
