Journalism students place high

Colby High School placed three students in the Kansas Scholastic Press Association state competition held last Saturday in Lawrence.

"This was the first time in the school's history that three students placed at the state level in this type of contest," said Donna Henry, high school journalism advisor.

The three placers were Alicia Leavitt, senior, Matthew Hull, junior, and Maret Peterson, sophomore, who were recognized for their work in editing, editorial cartoon and newspaper sports writing, respectively, Henry said.

Leavitt came home with a third place in the editing area; Hull was awarded honorable mention in the editorial cartoon category; and Peterson took honorable mention for sports writing.

"We took 11 students to the state contest, who were entered in 13 classifications," she said "Three students had double-qualified and the three who placed were also high school newspaper students.'

Other students who qualified for contest included Rachel Albers, sophomore, sports writing; Jamie Quenzer, senior, page layout and theme development; Kelsey Strickler, senior, yearbook copy editing; Leanne Juenemann, senior, yearbook copy writing; Elizabeth Merryman, senior, news writing; and Darla Nichols, junior, editorial

In total there were 139 high schools competing for placement in the contest with 1,034 entries submitted, she said. Students qualified for the state contest by placing at one of the six regional contests in February, Henry said.

The 18 categories available at the state contest included advertising, editorial cartoon, headline writing, newspaper design, yearbook copy writing, yearbook sports writing, cutline writing, editorial writing, infographics, newspaper and yearbook photography, yearbook layout, yearbook theme development, editing, feature writing, news writing, newspaper sports writing and broadcasting.

"This was the largest number of entries that qualified for state and the largest number of students who placed at state in Colby High School's history," Henry said.

Commission chair reports on meeting with hospital board

Sticking to a promise made earlier to a group of residents, Thomas County Commission Chariman crease in funding for 2004 due to Ron Evans met recently with the board of trustees of Citizens Medical Center and reported on that meeting during Monday's county commission meeting.
