Lena Patterson, who for more than 50 years

Williams Metzler to Edward Everett and Olive Coyle Metzler on July 19, 1905 in a sod house on a homestead near Ordway, Colo. She was the fourth of 10 children.

In 1926 she married Loyd Franklin "Pat" Patterson, who operated service stations and farmed in Colby most of his adult life. Except for briefly locating to eastern Colorado during the Great Depression, the couple lived in Colby throughout their lives. They had five children, all of whom graduated from Colby High School. Mr. Patterson died in 1965.

During her early youth Mrs. Patterson's family moved from the Colorado homestead to Sugar City, Colo. where they owned and operated a hotel. In 1913 the family moved to Mountain View, Mo. In 1915 Mr. Patterson's father came to Colby and secured employment at George Beaver's lumberyard. Mrs. Patterson's mother and the children followed, maing the journey in a covered wagon pulled by a team of horses.

In Colby as she grew to womanhood, Mrs. Patterson received her secondary education, worked at various times at the family-run dairy operation and as a housekeeper for Colby families, and Colorado Springs, Colo.; grand-Church in 1918.




