Shootout here leads to more federal charges

Colby Free Press Two men who led five law enforcement agencies through a chase in Thomas and Logan counties on Sept. 22, 2003 will face sentencing on May 17 at the federal courthouse in Wichita, said Kenna Rice, a spokeswoman for the federal attorney's office in Wichita.

Gerald N. Bryant, II of Inyokern, Calif. and Brian E. Berry, also of Invokern, pleaded guilty to federal charges in United States District Court for the District of Kansas Feb.

The two are currently being held in the Sedgwick County Jail, Rice said.

She said they both faced charges of one count each of conspiracy to distribute a controlled substance aiding and abetting, possession with intent to distribute a controlled substance, interstate and foreign travel in aid of racketeering enterprises, conspiracy to carry a firearm during and in relation to a drug trafficking crime, and using and carrying a firearm during and in relation to a drug trafficking crime.

Rice said Bryant pleaded guilty to possession with intent to distribute and using and carrying a firearm possession of drug paraphernalia.

during the drug trafficking crime. Berry pleaded guilty to interstate and foreign travel in aid of racketeering enterprises and using and the charge of carrying and using a weapon during the trafficking crime.

She said each man faces 10 years to life for the charges.

County Commissioner Ron Evans said County Attorney Allan Taylor will have to deal with the county charges.

"Whatever the county attorney says, that's his call," Evans said.

"I'm just glad they're taken care of at the federal level and we don't have to in Thomas County."

In Thomas County, Bryant was charged with five counts of attempted first degree murder, one count of possession of methamphetamine, one count of methamphetamine possession with intent to distribute and one count of possession of drug paraphernalia, which is a misdemeanor charge.

Berry was charged with one count of first degree attempted murder, one count of possession of methamphetamine, one count possession of methamphetamine with intent to distribute and one count of



City hall, old high school placed on historic rolls **By PATTY DECKER**

Free Press Editor Two Colby buildings were placed on the National Register of Historic Places recently, which is good news for the city and school district in preserving the past, officials here said today.

The newest additions to the register were the Colby Community High School at 750 W. 3rd St. and Colby City Hall, 585 N. Franklin, said Sue Taylor, director of the Prairie Museum of Art and History.

In addition to the old high school and city hall buildings, the Thomas County Courthouse and Colby Municipal Swimming Pool are already on the register.

"The Thomas County Courtregister in 1976 and the Colby historic buildings," she said.

"Placement on the register," she said, "recognizes that the property is significant to the nation, state and community.'

Mayor Warren Hixson said it is an honor to have city hall on the regis-

"We are preserving the history of our community by being added to the register," he said today.

"There's also opportunity to get preservation grants from the state, which in turn helps taxpayers and keeps the building in good repair." Carolyn Armstrong, city manager, said she agreed with the mayor in preservation efforts.

"It is important to preserve our house was placed on the national heritage by maintaining these older

placed on the register also opens up possibilities for grant funds to keep the building close to its original look

Taylor talked about some of the history associated with Colby City Hall noting that it was constructed in 1936 from native limestone from a quarry south of Monument.

'It was also designed with Art Deco influences." she said, "and Suite and Blanched, from Garden City, were the architects."

The money to build city hall came from Works Progress Administration or WPA funding, which was a way to get unemployed men government funded jobs. Colby Community High School also received that type of funding.

Armstrong added that being Colby Schools, said he too is ex- rium, the arched casement wincited about the announcement recently.

"I believe if a building has historic value, it should be fixed up or taken care of," he said. "It bothers me when I see buildings torn down that contain so much history --- we need to preserve these structures when possible."

The old high school was built one year prior to city hall in 1935, Taylor said.

In addition, the architects incorporated regional decorative motifs such as half-husked ears of corn, banded reeds, and sheaves of wheat.

"These images reflected and honored the agricultural heritage of the community and the style is evident in the low gabled French tile roof, Kirk Nielsen, superintendent of the arcaded entrance to the audito-

dows, the tower and the asymmetrical plan of the building," Taylor added

As officials noted, there are many benefits to being on the national register. Among those are grants and state and federal rehabilitation tax credits.

The Kansas State Income Tax Credit of 25 percent, Taylor said, can be used on certified rehabilitation of both Kansas and National Registered properties and the federal investment tax credit of 20 percent can be used on certified rehabilitation.

"I think this shows once again that the Thomas County Historical Society is leading the way in preserving our heritage forever," Nielsen said.
