# **Colby street project** hits snag at meeting

Free Press Editor One councilman asked for more time to review a petition requesting improvements to Copeland Avenue from W. 5th to W. 7th Streets during Tuesday's Colby City Council meeting.

After hearing from homeowners and fellow council members, Jim Tubbs asked if the issue could be tabled until the next meeting thereby giving him time to look over the proposal and street in question.

Prior to Tubbs' request and after some discussion, Councilman John Bremenkamp made a motion to approve the street project, but the action item failed for a lack of a second.

The petition and improvements proposed would result in the widening of Copeland Avenue, make improvements to the storm sewer and add curb and guttering at an estimated cost of \$38,900 was initially brought forward to the council with 53 percent of homeowners signing.

However, Todd Voss, representing Voss Rentals, LLC and Paul Larry and Sarah Jane Barrett and Bedore, speaking for Colby Sixth Street Club, both voiced concerns with the street improvements. There were also others in favor of the improvements at the meeting.

Voss told the council that he cannot understand why there is a need for tearing up the yards of three homes in that vicinity and why there needs to be improvements on a drainage area that has always been there.

As for the petition, both Voss and Bedore said they have never seen a approve the widening and upgrades petition or been able to sign off on on Copeland Avenue, Joel Kriss, to talk with him about it.

"Everybody should have had a chance to look at the petition," Tubbs said. Although Mayor Warren Hixson pointed out that sometimes when a petition reaches the 52-53 percent of acceptance, the petitioners stop circulating it.

The percentage of those opposing the new street is estimated at 47 percent, according to information provided at the council meeting.

It was not confirmed at the council meeting as to whether or not those who failed to sign had even seen the petition.

city attorney, said it would not require a public hearing. The only thing necessary, he said, was verifying the percentages, which was already completed by Greg Gordon with Gordon Company.

Opponents of the street upgrades also questioned whether or not it could be done without a recommendation from the state.

Bedore said it was his understanding, based on conversations he had with a state official, that any time there is a change in the water drainage from the existing area, it will require a state recommendation.

In this particular situation, Kriss said he didn't believe that would be necessary since the change appeared to not be significant enough to change the water flow from the original draw on the north end of Copeland where the widening would occur.

Another issue Kriss brought up was the fact that under statutes, the city is not required to act even with a petition based on the language noting that the wording is "may" and not "shall."

In addition to tabling the issue until Tuesday, March 30, Tubbs suggested that owners wanting to offer their opinion are encouraged

TOPEKA (AP) — With a plan from House Republicans for increasing school funding by \$92 million facing debate in committee, the GOP is far from united.

"Trying to get Republicans to agree is hard, let alone 125 people," said House Education Committee Chairwoman Kathe Decker, R-Clay Center.
