## 'Nightline' to put face on war in Iraq

You may want to watch ABC-TV's "Nightline" tonight (ch. 6, right after the news). Host Ted Koppel will read the names of the more than 700 American servicemen and women who have died in Iraq since the invasion slightly more than a year

The program will be extended to allow for the roster to be read and pictures of the war dead to be shown.

Of course something of this note attracts controversy. "In poor taste." "They shouldn't be so insensitive." "They are invading families' privacy." Etc. Etc. Etc.

But this is war, make no mistake about it. And in wartime people lose their lives. And, quite frankly, "Nightline" will be providing a service to this country when it embarks on the roll call. They will be putting human faces on the situation in Iraq. And probably any number of viewers will learn for the first time that families they once knew who now live in other areas of the country have lost a child in the war.

We doubt it will hurt troop morale. Those in uniform will have reason to stand proud and salute those who have given the ultimate sacrifice for their country, and also knowing that with this solemn declaration of recognition by "Nightline" that they have the support of the people back home.

We are going to watchit. We may even be among those learning of war deaths that involve people we used to know.

Those who have died on the Iraqi battlefield did so for a cause, a noble cause — freedom. And freedom allows those in opposition to the "Nightline" feature to say so. It allows "Nightline" to do so.

You can watch the program tonight. Or if you choose you can surf to another channel. Freedom of the fingers.

We can find no reason to be critical of the program.

And, likewise, we can find no reason to be critical of those who do.

## May produces most tornadoes

WEARE far from out of tornado time in Kansas. In fact, according to research shared by the National Weather Service over at Goodland a shot time ago, in the year 2003 the most tornadoes occurred in the month of May. And if you look at your calendar, we move into May 2004 tomorrow.

May 2003 produced a total of 44 tornadoes in the state, and it may interest you to know that nearly half of all the tornadoes in all of 2003 (91) occurred between May 4 and May 15. Those 91 tornadoes last year were 39 above normal.

The 2003 death toll statewide was 8, the most since 1991. And there were 84 injuries, also the most since 1991. The longest track was 27 miles reported in Crawford County on May 4.

The strongest were F4s, and there were two of those, in Crawford and Wyandotte counties on May 4. Those were the first two F4's in one year since 1993. Labette County reported the most tornadoes in 2003 with seven. The most tornadoes reported in a single day statewide were 21 on May 8.

The first tornado reported in 2003 was on March 12 in Labette County, and the last touchdown was on Aug. 5 in Crawford County.

Property damage from the 91 tornadoes was estimated at \$59 million. On May 15, 2003, an out break of eight tornadoes in southwest Kansas produced \$15 million

damage in and near Liberal in Seward County. In June of 2003, tornadoes favored northwest and north central Kansas, although fewer tornadoes than normal were reported across western

and southeast Kansas was well above normal. Here is the monthly breakdown of Kansas tornadoes in 2003: January and February, 0; March, 1; April, 12; May, 44; June, 22; July, 11; August,

Kansas. The number of tornadoes over eastern

1; September through December, 0. Since 1950, Kansas has reported a total of 2,794 tornadoes. During that 54-year period that averages out to be 51.74, or rounded off to 52 per year. May was still the most active month over that time frame with 967.
