- 6) Knowingly operating the sexually oriented business during a period of time when the licensee's license was suspended
- 7) Is delinquent in the payment to the City of taxes, fees, fines, or penalties assessed against or imposed upon the applicant in relation to a sexually oriented business
- 8) Has been convicted or entered a guilty plea to a criminal activity involving a sexual act or been placed on diversion for such acts under the laws of the State of Kansas, or a law of another state, or an ordinance of any city or resolution of any county which prohibits the acts this section prohibits.

Employee does not include a person exclusively on the premises, for the delivery of goods to the premises.
- Enforcement Officer shall mean the City Building Official or such person as may be designated by the City Manager
- Escort means a person who, for consideration, and for another person, agrees or offers:
  - to act as a companion, guide, or date, or 1)
  - 2)to privately model lingerie, or
  - to privately perform a striptease. 3)
- Escort Agency means a person or business association that for a fee, tip, or other consideration, furnishes, offers to furnish, or advertises to furnish, escorts as one of its primary business purposes
- Establish or Establishment means and includes any of the following
  - 1) the opening or commencement of any sexually oriented business as a new business
  - 2) the conversion of an existing business, whether or not a sexually oriented business;

- Licensee means a person in whose name a license to operate a m. sexually oriented business has been issued, as well as the individual listed as an applicant on the application for a license; and in the case of an employee, a person in whose name a license has been issued authorizing employment in a sexually oriented business.
- Nude, Nudity or a State of Nudity means the showing of the human male or female genitals, pubic area, vulva, anus, or anal cleft with less than a fully opaque covering, the showing of the female breast with less than a fully opaque covering of any part of the nipple, or the showing of the covered male genitals in a discernibly turgid state.

- Substantial Enlargement of a sexually oriented business means the y. increase in floor areas occupied by the business by more than twenty-five (25) percent, as the floor areas exist on the date this Ordinance takes effect.
- Transfer of Ownership or Control of a sexually oriented business means and includes any of the following:
  - 1) the sale, lease, or sublease of the business;
  - the transfer of securities which constitute a controlling 2) interest in the business, whether by sale, exchange, or similar means; or
  - the establishment of a trust, gift, or other similar legal 3) device which transfers the ownership or control of the business, except for transfer by bequest or other operation of law upon the death of the person processing the ownership or control.

SECTION 3: That "Use Regulations" in Article 1, Section 21.112. I-1-Light Industrial District, be revised to include the following:

SECTION 4: That "Use Regulations" in Article 2, Section 21.202. Special Permits, be revised to include the following:

21-202. Special Permits

Insert the following as Paragraph 11.:

- Sexually Oriented Businesses may be located in I-1, Light Industrial 11. District, provided the following procedures are complied with:
  - No sexually oriented business may operate within three hundred a feet (300') of any existing residential zone as measured from property line to property line.
  - No sexually oriented business may operate within three hundred b. feet (300') of any existing public, private, or parochial school; library; park; playground; church; or <u>other place where minors</u> <u>tend to congregate</u>; measured from property line to property line.
  - No sexually oriented business may operate within three hundred с. feet (300') of any other sexually oriented business as measured from property line to property line.
  - No sexually oriented business may operate on any premises licensed pursuant to the alcoholic beverage control regulations of d. the State of Kansas
  - Hours of Operation. No sexually oriented business, except for an e. adult motel, may remain open at any time between the hours of one o'clock (1:00) A.M. and eight o'clock (8:00) A.M. on weekdays and Saturdays, and one o'clock (1:00) A.M. and noon (12:00) P.M. on Sundays
  - No sexually oriented business shall allow entrance to any person under the age of eighteen (18); noncompliance with this provision f. may result in revocation of the sexually oriented business license.



Failure to Comply; Penalty. Should any person, corporation, n. partnership or association fail to comply with any provision of this Ordinance pertaining to sexually oriented businesses, the public officer may file a complaint in the municipal court of the City against such person, corporation, partnership or association and upon conviction of any violation of the same, be fined a minimum on the first conviction of \$200.00, upon a second conviction of \$400.00 and a maximum amount not to exceed \$1,000.00 on said first, second or any subsequent conviction or be imprisoned not to exceed 30 days or be both fined and imprisoned. Each day during or on which a violation occurs or continues after notice has been served shall constitute an additional or separate offense

SECTION 5: This Ordinance shall take effect and be in force from and after its passage and publication once in the official City newspaper.
