Arizona College of Osteopathic Medicine was where he completed


nis pre-med work. Kellogg completed his residency at the University of Missouri-Kansas City.

Genesis-Thomas County food bank needs a little help. Treasurer Geri Landry said today a summer of helping families has left shelves more empty than usual for the time

The Goodland Star-News GOODLAND—Police arrested the Goodland High School football coach on suspicion of arson late Saturday after a second fire at his

Coach Tony Diehl, 34, 1108 Harrison, was arrested about 12:30 a.m. Sunday, Chief Ray Smee said.

The fire was set with gasoline on the back side of the roof of the house, neighbors said.

The coach had complained of vandalism and at least one arson attempt at his home in the last couple of weeks, after he reported a teen-age party to the sheriff's department. He said the windshield was broken out of his pickup, and someone had attempted to set fire to

Police watching for vandals apparently caught the "victim" instead.

Lowell Lambrecht of 1109 Harrison, and his brother-in-law Marty Ross of Colorado Springs, who was visiting, awakened him when Ross saw the flames at Diehl's to help put the flames out with a rived," Smee said today. garden hose.

glass of water and saw the flames, and woke me up and we went over to help," Lambrecht said. "I don't understand what happened with him. He is a pretty good guy, and has been a good neighbor. I can't understand it. "I feel sorry for him, and feel it

the area quickly and they kicked in the front door to get Diehl out because of the fire. Diehl's wife, Tiffany, and son, Dietrich, were out of

Diehl was taken to a police car in front of his home and put in the back seat to keep him warm. Neighbors gathered on the street to watch and wonder at who could have set the fire. Smee said Sunday that after the fire was put out, officers got permission from Diehl to search the house, and then arrested him and took him to the Sherman County Bastille.

Chief Smee said he talked to Lambrecht and Ross to let them know his officers were about to arrest the coach.

"I felt they needed to know," Smee said, "and it was a way to calm the neighbors fears that someone was coming into their area and doing this.

'We have been working on this case, and have had extra people watching the area to try to catch whoever was doing these things. We are glad we were able to be on the scene at the right time. The investigation is not over, and we con-

tinue to look at all the events of the past two weeks."

Lambrecht said he was glad Smee had explained the situation before they hauled the coach away.

"I know living across the street I had been worried about these things taking place," Lambrecht said. "I was trying to guess — like everyone else — who might have been doing it, and was completely surprised when Smee said it was the coach himself. I wish the best for him, and hope he can get some help. It seems like he had to get this done and get caught before he had to face teaching or coaching this week."

Lambrecht said a neighbor lady who lives across the alley behind Diehl's home had seen the coach on the roof before the fire started.

The fire Saturday was reported about 11 p.m., and was the second arson fire reported at that address in a week. Smee said a 911 call came into the dispatch center at 11:10 p.m. that the roof of the house at 1108 Harrison was on fire.

He said that it had been set. On Wednesday, Diehl reported at 2:15 a.m. that a tire on his pickup had been slashed.

> Smee said the investigation continues, and he does not know at this time if all of the previous incidents were done by the same person.

"We are gathering evidence," Smee said, "but we do not know if all these were done by one person. If there are others involved, we would like to catch them and bring them all to justice. 'The Sherman County Sheriff's

department and the city police are investigating the arson.'

Diehl is to be advised of charges against him in court this week.

Man dies in crash near Oakley

A Wichita man died early Saturday morning on Kansas Highway 25 south of the Logan/Thomas County line after failing to maneuver a curve, said the Kansas Highway Patrol. The one-vehicle accident involved the driver, Kenneth Ray Walker, 39, who was taken to Kennedy-Koster Funeral Home and one passenger, Justin Billy Adams, 21, who was ejected from the pickup and currently is hopitalized at the Logan County Hospital in Oakley. Walker was traveling southbound at about 3 a.m., said an official with the Kansas Highway Patrol, when he apparently continued driving straight instead of making the curve at milemarker 178 on Highway 25. The 2000 Ford pickup then left the roadway, entered the west ditch, struck an adjoing road embankment and went airborne about 55 feet before landing upright in a dirt field, officials said today.
