

In addition, Boardman could be facing revocation of her probation with respect to similar-type charges in February of 2004.

As part of the plea negotiations in September of 2004, the court agreed to grant a diversion on 7 of the 11 charges dealing with burglary and removing prescription drugs from homes without permission.

She also, at that time, agreed to waive a preliminary hearing, entering a guilty plea Boardman was arrested on Feb. 13, 2004 on one count of theft and one count of pos-

sessing a depressant — both being misdemeanor charges.

Magistrate Judge Rick Ress, who will again be presiding in August, agreed to Boardman paying court costs and suspension of one year jail time with supervised probation.

The court said probation was conditional in that Boardman would agree to no violations in the law within that year, compliance for repaying the costs and successful completion of the felony diversion.

Helicopter crash in Kabul may have been costly

Rescuers have reached the wreckage of a U.S. special forces helicopter that crashed in a rugged mountain ravine in eastern Afghanistan, but there was no immediate word on the fate of the 17 troops on board, a U.S. military spokesman said today.

"We are at the wreckage as we speak," Lt. Col. Jerry O'Hara told The Associated Press. "We are conducting search and recovery operations. But we are more into the recovery stage."

KABUL, Afghanistan (AP) — forts to find survivors or the bodies later Thursday. of the 17, who were believed to have died in Tuesday's crash.

> The British Broadcasting Corp. reported on its Web site that U.S. officials at the main American base near the crash site said 13 bodies had been recovered. Seven other soldiers, including some that were fighting on the ground, were missing, the BBC reported.

U.S. spokeswomen Lt. Cindy Moore declined to comment on the report, saying the military would He declined to elaborate on ef- release a new statement on the crash

A military statement said U.S.led coalition forces were "currently assessing the cause of the crash and the status of the 17 servicemembers who were on board the MH-47 helicopter."

O'Hara said "there are still bad guys in the area" around the crash site and that troops were having to "do a recovery and a tactical operation at the same time.'

Militants are believed to have shot down the MH-47 helicopter as it was bringing in reinforcements

for a battle with suspected al-Qaida fighters.

A storm that hampered rescuers from reaching the wreckage Wednesday had passed by Thursday. Recovery operations also have been made difficult by the rugged terrain of the remote crash site, reachable only by foot, and continued fighting with militants.

Officials in the United States said they knew of no communications from the crash site near Asadabad, in eastern Kunar province
