Donation assures fence and gazebo at Colby Complex

Colby Free Press A memorial donation will allow construction of a fence and gazebo at Prairie Senior Living Complex. According to Janice McCart, administrator, trustees at Citizens Medical Center met on July 7, for their regular monthly meeting. The trustees learned a donation from the Alberta Myers' family will enable the complex to install vinyl fencing on the southwest and southeast sides of Prairie Senior Living Com-

In addition, the same memorial donation will allow a gazebo to be built on the southeast side of the building, the side designated as the special care unit, McCart said. A dedication of the project is scheduled for Aug. 16.

McCart said the trustees approved credentials for various local and visiting medical staff. Those approved were Martin H. Kinsman, physician's assistant from Hays, John F. Patterson, certified registered nurse anesthetist working at the hospital, Jenny Niblock, nurse practitioner at Family Center for Health Care.

Consulting physicians approved were Raymond W. Smith and Michael J. Wright, both of Hays, William S. Clifford, Garden City, James C. Holmes, and Denver.

McCart said the trustees reviewed and approved policies and procedures for the acute care substance abuse program, and made a minor change in the human resource holiday pay policy. In the past, only employees designated as full-time or part-time were paid holiday pay. This left out certain employees which were call in on an as-needed basis.

McCart said changing the wording in the policy to "any hourly employee" will now designate those called in on an as-needed basis, as well as those working fulltime or part-time, will receive holiday pay.

Two judges order Quinter resident to prison term

Colby Free Press HOXIE—Two area judges have ordered a Quinter man to prison, but it's not certain how long he'll be

Tuesday morning, District Judge Edward Bouker, Hays, revoked 21year-old Bobby J. Harvey's probation in Gove County District Court. Tuesday afternoon, District Judge Glenn Schiffner did the same in Sheridan County District Court. how long Harvey will be confined, because while the two judges were aware of each other's court date with Harvey, they didn't know each other's intent for his sentence.

Sheridan County for two crimes he committed in Hoxie - a May 2003 break-in at Heim TV and Appliance and an October 2003 break-in at Mader Liquor. Last year, Schiffner ordered Harvey to serve 12-month probation, with an underlying prison term of 9-months. He also ordered Harvey to pay \$500 restitution to Heim's, and \$10,000 restitution to two insurance companies covering the businesses. But, since But, there is some confusion about Harvey didn't pay the restitution, Schiffner extended his probation an additional 12 months.

Harvey was on probation in of 30-months, for breaking into Harvey's sentence torun at the same stand, but said Harvey will serve parked cars at North Shop in time as the one in Gove County afbreak-ins helped tie Harvey to the Quinter break-ins and both sentences were being served at the same time.

Now that Harvey's probation has been revoked in both counties, it's still unclear if he'll serve 30 months in prison or 39 months, with time off for good behavior.

Prior to the hearing in Hoxie, Gove County Attorney Mark Schmeidler said Bouker ordered that the sentence in Gove County was "not to run concurrent with the Sheridan County term." But Tuesday afternoon, Schiffner ordered

Bouker disagrees.

According to court documents, which followed the hearing in Harvey's probation was revoked because he had "violated traffic laws, associated with the co-defendant in the case (Jonathan Harvey), failed to maintain suitable employment, left Gove County without permission and absconded from

Harvey's probation officer, Justin Herbel, Hays, said Harvey also has a pending case against him in Sedgwick County on possession of marijuana with intent to sell. No Bouker said he would not issue an other information about that case
