## Sheriff's office makes arrests in Brewster

BREWSTER—Multiple calls to the law enforcement center in Colby took sheriff's deputies to Brewster the past few days. On Thursday, Aug. 25, Martha

Yefenia Marcado, 27, was arrested as an illegal alien when she was located near Levant.

"I don't know the underlying charges of why she was deported, but she was taken in and turned over to the Immigration and Naturalization Service on Friday," said Sheriff Mike Baughn this morning.

Other activity taking deputies to Brewster included one case of a man giving alcohol to minors, a case of battery and damage to a

Colby man's car. On Friday, Aug. 26, at 10:40 p.m., Michael W. Kline, 28, was ticketed for furnishing alcohol to minors, Baughn said. No court date has been

set yet for Kline. Baughn said at 10:28 p.m. on Saturday, a 44-year-old male called authorities and reported he'd been

beaten at his home.

"It's a battery case," Baughn said. "We couldn't find the suspect at the

time, but charges are pending." Also on Saturday, Donald Headley, Colby, called authorities

to investigate damage to his car which had been parked in a friend's driveway in Brewster. Baughn said Headley's car had its

windshield shattered and all the other windows completely broken out of it. In addition, the car's roof was caved in and its gas cap stolen.

"We have a suspect located and charges of criminal damage to property have been sent to the county attorney," Baughn said.

# Colby woman's furniture is being held 'hostage'

Colby Free Press A dispute between a Colby woman and a moving company she believes is holding her furniture hostage may be headed to court.

When Barbara Young, 71, married Ben Duell, 74, they decided to sell her home in Oberlin and his near Ruralton and move to Colby. But a move Young-Duell thought would cost her less than \$3,000 could end up costing her between \$11,000 and \$15,000.

Young-Duell contacted the move of her four bedroom with basement household to Wilson Moving Company in Hays. But shortly before the June 6 packing date, the company went out of business. Wilson Moving subcontracted the job to Wegele & Wegele Vanlines, Inc., Pratt.

"I talked to Mrs. Wegele on the phone and she told me they needed cash to deliver my furniture," Young-Duell said.

"I told her I'd pay cash and I'd get about \$2,600. She told me that would probably be enough." The dispute started when Blaze

Wegele and his crew tried to deliver Young-Duell's furniture at the house in Colby. "Blaze came in and started figur-

ing my bill and he said I needed \$8,880 in cash. I just couldn't believe it. He said he hauled 16,000 pounds," she said. Young-Duell said when she dis-

Wegele left her a kitchen table, three deprive. mattresses, a card table and chairs, a few clothes and odds and ends of

According to paperwork Young-Duell received from the Wegele's, she can go to Pratt and pick up her belongings for \$11,088, or have side Wilson's estimate and included them delivered for \$14,065.
