Marie said before they opened, the closest places to go for used books were McCook, Neb. or Denver. She said people shouldn't have to drive that far to buy something to read. She said people don't read as much as they used to but they should take the time to make it a part

They have more than 10,000 used books, including children's literature, classics, westerns, fiction, non-fiction, scifi, romance and more. The store also has a selection of new Christian books.

"We will order new and used books," she said.

James said people are happy to have another book store in town but not many know they're in opera-

"Our problem is that people don't know about us," he said. "We need more people to know we're here. We carry a large variety of things."

They also carry devotional items, used DVDs, T-shirts and more. He only wanted to have used

books but she thought they could combine it with devotional items instead.

"We're two stores in one," Marie said. The Thomas County Free Fair parade and All-School Reunion at the beginning of August both helped with business. Marie said they've started children's reading groups, which include arts and crafts and reading a book. They've also talked about starting an adult reading club. She said other places have had a program called "kill your television" where people spend time reading instead of watching


