Sam Houston Parkway S, P.O. Box 4666, Houston, Texas 77210. The facility addresses that are a subject of this penalty assessment are known as the Oakley to Colby Line in Thomas County, Kansas, and the Colahan Lease in

rized to issue orders assessing civil penalties for various violations of the Clean Water Act. The EPA may issue such orders after filing a Complaint commencing a Class II penalty proceeding. The EPA provides notice of the proposed assessment of a Class II penalty pursuant to 33 U.S.C.£ 1321(b)(6)(C)(ii). Class II proceedings are conducted under EPA's Consolidated Rules, 40 C.F.R. Part 22. In this case, the EPA has filed a combined Complaint and Consent Agreement and Final Order, alleging that on or about November 10, 2002, Respondent's former facility caused a discharge of oil into or upon an unnamed tributary of the South Fork of the Saline River, and on or about May 16, 2003, caused a discharge of oil into or upon an unnamed tributary of the Saline River, in a quantity determined may be harmful to the public health or welfare of the United States, and therefore, violated Section 311 of the CWA, 33 U.S.C. 1321. The Consent Agreement and Final Order resolves these alleged violations for a proposed penalty of \$73,810.00
