

Woman pleads to burglary

An Oakley woman who changed her story during a hearing in January was sentenced Wednesday in Thomas County District Court.

After Goldie Moore, 22, pleaded guilty to one count of burglary she changed her story and said she did not enter Murray Enterprises, Murray Roofing, JM Tree and Lawn Service and Sundance Spas on Nov. 23.

Moore and co-defendants Eric Schiltz and Lewis M. George, both of Oakley, were arrested in December after fleeing the area in December.

Sitting beside her attorney, Doug Spencer of Oakley, Moore told Schiffner she didn't have anything to say to the court or her victims prior to sentencing.

Moore, who is several months pregnant, was sentenced to an underlying prison sentence of seven months and placed on probation for 12 months. In addition, District Judge Glenn Schiffner told Moore she must serve a 12 month post-release probation period.

Moore must pay restitution to Murray Enterprises in the amount of \$3,814, as well as court costs and attorney fees amounting to \$802.

In February, Moore pleaded guilty in Logan County to one count of failure to reveal a runaway for allegedly sheltering or concealing a runaway child from authorities on or about July 24. She was sentenced to six months on probation with an underlying jail term of 90 days should she violate her probation.

Besides the charges in Thomas and Logan Counties, Moore has pending forgery charges against her in Ellis County for her alleged part of passing worthless checks with Schiltz and George in December.

barrel in the back of the van when she drove away on Feb. 12. He said Young "almost wrecked the van" when he jumped out 10 minutes later.

Manard also claims Young at first wanted to go back and explain that the caper had been a mistake, but he convinced her that prison officials wouldn't be understanding. And after seeing her picture on the "America's Most Wanted" television show, she was "scared to death to leave me," he wrote.

Department of Corrections spokesman Bill Miskell said Thursday that investigators had sufficient evidence the day after the escape to receive warrants for Young's arrest for aiding Manard's escape.

And he reiterated earlier reports that prison officials believe Young bought a new car without her family's knowledge, took two guns from home, amassed thousands of dollars in cash and bought hair dye and an electric razor before the escape.

Young is charged with aiding and abetting aggravated escape, and harboring and concealing a felon. Her attorney did not immediately return a phone call seeking comment Thursday.
