
Colby College board meets Thursday

Senate endorses ed plan

TOPEKA(AP) - A\$660 millionschool finance plan cleared a Senate committee Monday, but its future was uncertain.

The Education Committee's 6-5 vote sent the legislation to the Senate for debate, probably next week. The bill phases in the spending increases over three years. The plan, drafted by Senate lead-

ers, emerged from committee largely intact.

The committee's biggest change was to allow districts to use additional dollars set aside for programs that help at-risk students to also pay for all-day kindergarten.

The committee's vote was the first major action on school finance pass the chamber.
