Former Colby Trojan faces rape charge

A Colby attorney is trying to figure out why his client's scholarship at a Missouri university was not renewed for another year.

Southeastern Missouri State University officials are saying little about the July 27 announcement that Andrais Thornton's scholarship was dropped and he is no longer on the basketball team. That announcement opened the door for questions by his attorney.

"We are looking into it," Todd Stramel said Monday. Thornton was arrested in January on the university's campus located in Cape Girardeau on rape and aggravated sexual battery charges filed in Thomas County.

Charges stem from an alleged assault of a then 19-year-old college student and cheerleader on Nov. 16, 2003, Colby Community College campus.

Head coach Scott Edgar made the announcement about the 21-year old Chicago native's scholarship and roster spot. Edgar was not available for comment on Monday and Toby Lane, assistant coach, refused to talk about the situation. University Sports Information Director Ron Hines did not offer details.

"His scholarship was not renewed," Hines said.

Asked whether the action by the university has anything to do with Thornton's pending trial in Kansas and Hines said, "No comment."

Thornton played basketball for Colby Community College during the 2003-04 basketball season.

He spent his sophomore year at Southwest Missouri State-West Plains Community College in

West Plains, Mo., then transferred to Southeastern Missouri State where he averaged 7.9 points and a team-high 6.6 rebounds per game for the Redhawks in 2005-06.

Thornton's four-day trial in Thomas County District Court in Colby will begin Nov. 13.

Thornton, 18 at the time of the alleged incident, denied the charges against him at a preliminary hearing May 9.

During that hearing, Stramel took the position the case was a "bad case" from the start. Assistant Kansas Attorney General Nola Wright and Thomas County Attorney Andrea Wyrick believe differently and are moving the case forward to trial.

The alleged victim claims she and a second woman who is not pursuing prosecution of Thornton and a co-defendant, Ontario McKee of Milwaukee, Wis., were attacked by both men.

She said she and her friend attended at least two parties, one on campus and the other in a downtown apartment, where they drank heavily before the alleged attack.

McKee, 19 at the time of the alleged incident, was arrested in January at San Angelo University in San Angelo, Texas. McKee, as part of a plea agreement, pleaded guilty to sexual battery and was ordered to unsupervised probation.

Should Thornton be convicted of the rape charge, and depending on a presentence investigation, he faces 20 to 54 years in prison and a fine up to \$300,000.

Should he be convicted of the aggravated sexual battery charge, he faces four to 11 months in prison and a fine up to \$300,000. Thornton remains out of jail on \$100,000 bond awaiting trial.

A Colby High School and Colby Community College graduate recently completed basic military training.

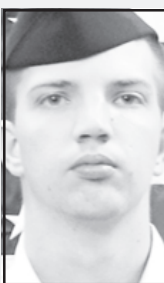
U.S. Air Force Airman 1st Class Christopher M. Barnum completed his six-week training at Lackland Air Force Base in San Antonio, Texas.
