Brewster soldier hurt in Iraq war By Jan Katz Ackerman Colby Free Press

A former Brewster man believes guardian angels were with him and his crew when their military helicopter crashed Dec. 10 in Iraq.

"I'm OK,"Sgt. Jesse Doze said today from Brooke Army Medical Center in San Antonio, Texas. "I'm waiting on surgery and I'm in a lot of pain.'

Doze, 29, is assigned to the 3rd Battalion, 4th Weapons Company of the Marine Corp Air Ground Combat Center at 29 Palms, Calif. He was one of 21 military personnel traveling in the helicopter when the pilot lost visibility believed to have been from either a brown out or having been shot down.

of a helicopter is open and dust from whirling blades gets inside and obscures the view. The crew was on a training operation and were returning to the base at Al Qu'im when the crash happened.

The crashed caused one fatality, and 10 of 18 personnel injured were treated and released back to active duty. A helicopter directly in front of the one on which Doze was riding landed safely. The crash is under investigation.

Doze said he remembers when the helicopter hit the ground and that it hit nose first.

Doze said he went in and out of consciousness for an undetermined

"I woke up a couple times and the next time I woke up I was outside of the helicopter just looking at it," he said.

Having injured to his pelvis, back and shoulders, Doze said he will require surgeries and rehabilitation expected to last about a year.

"I'm done for now," he said. "But the Marines have a policy they'll find a job for whoever wants to stay in after an injury.'

Family members and friends have rallied around Doze to help him through his recovery.

"He's a very fortunate young man," Doze's brother Dustin said. Dustin Doze resides in Syracuse and was at the airport in Texas when the transport plane carrying his brother arrived.

"He is doing fine today," Dustin said. "He just visited with the orthopedic surgeon and his hip surgery is scheduled for Wednesday or Thursday. He's stable and doing well."

Brewster resident Bonnie Reid is a long time family friend of the Dozes and has been keeping in contact with the family.

"They feel like it was a miracle," Reid said. "Vicki and Kent went to Houston, Texas 78234.

Reports from the Doze family to was on a pile of Marines and then Faber indicated Doze's hip socket was shattered but the femur bone was not injured. Doze also has a burn on the calf of his leg. The shape of the burn is being suspected to have been caused by Doze's leg on something that was hot after the helicopter, which rolled several times, hit the ground.

> Part of the miracle being talked about is the fact the helicopter was carrying more fuel than usual when it crashed but it did not explode on impact.

> "There is not doubt in my mind that there were angels on board protecting these Marines from even more serious injuries, not to mention the fear of exploding," Doze's mother, Vicki, wrote in an e-mail Faber shared.

> Doze's sister-in-law, Karen, stayed behind in Syracuse and said the family appreciates the thoughts and prayers for Jesse.

Judge to consider doctor's lawsuit

A judge will determine at 10 a.m., Tuesday in the Thomas County Courthouse whether a Colby doctor has sufficient cause to move forward on a lawsuit he filed against Citizens Medical Center suspending his privileges.

Hutchinson attorney Mike O'Neal, representing Dr. Victor Hildyard, filed the suit eight months ago alleging the Colby hospital did not follow its own bylaws when it suspended Hildyard's privileges in April 2003. Defending the hospital, Carol

Bonebrake of Topeka, filed a motion for dismissal stating the hospital is a private and not-for-profit organization and its decisions are

not subject to court review. hospital suspending Hildyard's privileges more than three years ago, two other attempts to suspend the doctor's privileges were reversed by the Thomas County



In April 2002, Hildyard's hospital privileges were suspended following an employee complaint, which was handled by the hospital Hildyard's privileges in April 2003 as an issue under its Hostile Work based on what O'Neal alleges was Environment Policy, according to the petition.

That suspension was reversed by Nov. 20-22, 2002.
