Driver seeks lesser charges

LAWRENCE. (AP) — A woman charged with fleeing after two highway workers were killed is trying to get her bond lowered and the charges against her reduced.

In a letter to the Osage County magistrate handling her case, Ramona I. Morgan also said she has fired her attorney because he failed to get her bond in that county reduced to less than \$1 million.

Morgan, of Chewelah, Wash., faces charges in Douglas and Osage counties over the Sept. 11 deaths of state Department of Transportation workers Tyrone T. Korte, of Seneca, and Rolland Griffith, of El Dorado.

Prosecutors say she and her daughter were driving the pickup that struck the two men as they worked along a stretch of U.S. 59 south of Lawrence. Charges against the daughter have since been dropped.

Morgan faces two counts of second-degree murder in Douglas County, but officials there don't plan to begin their prosecution until after the Osage County case is resolved. In Osage County, she is charged with fleeing law enforcement officers, a felony; reckless driving, a misdemeanor; and four traffic infractions.

She wants the charges in Osage County reduced to a single count of speeding. Magistrate Jon Stephen Jones had a hearing in her case Wednesday, declining to reduce her bond.

The Lawrence Journal-World reported that in her letter, she wrote: "I have spent 99 days in jail. Please consider time served, probation and a \$500 fine."

The magistrate told Morgan that the county attorney must decide whether he wants to reduce charges. The county attorney, Brandon Jones, who's not related to the magistrate, said he does not plan to do so.

Morgan accused the court of being prejudiced against her because she is from another state.

The magistrate told her: "Be careful what you say."

She told the magistrate that she needs three weeks to find a new attorney, and he set another hearing for Jan. 10. The magistrate previously had lowered her bond from \$2 million to \$1 million. Her bond in Douglas County is \$200,000.

The Osage County attorney argued against reducing the bond, saying Morgan is a danger to the community and there is a high risk she would not show up for court if released.

Morgan replied: "He says that every time I go to court. I don't appreciate that."

ORDINANCE NO. 1437

AN ORDINANCE DESIGNATING TERM OF OFFICE, COMPENSATION, QUALIFICATIONS, AND DUTIES OF THE CITY ATTORNEY OF THE CITY OF COLBY, KANSAS, AS AUTHORIZED BY K.S.A. 14-201 AND 14-205; REPEALING ORDINANCE NO. 1419 DATED FEBRUARY 20, 2007.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF COLBY, KANSAS:

SECTION 1. CITY ATTORNEY APPOINTMENT AND TERM OF OFFICE. The City Attorney shall be appointed by the Mayor, by and with the consent of the Council, for a term of one year, the term beginning each year on January 1, and until their successor is appointed and qualified;

SECTION 2. CITY ATTORNEY ELIGIBILITY. No person shall be eligible for the office of City Attorney who is not by profession an attorney-at-law admitted to practice in the Supreme Court of Kansas;

SECTION 3. CITY ATTORNEY QUALIFICATIONS. The City Attorney shall be a qualified elector of Thomas County;

SECTION 4. CITY ATTORNEY COMPENSATION. The Salary of the City Attorney for the 2008 term is \$125.00 per hour, staff expense of \$575.00 per month, paid membership for the Kansas City Attorneys' Association, and reimbursement for registration fee, mileage, and lodging to attend the Annual Meeting.

SECTION 5. CITY ATTORNEY JOB DESCRIPTION. The duties and responsibilities of the City Attorney within the monthly salary shall be:

- The City Attorney shall represent the City of Colby and shall perform all duties required of city attorneys of a city of the second class within the State of Kansas as required by the laws of the State of Kansas; and, further, all duties as required by ordinances passed by the City of Colby, Kansas, provided, however, that the City Attorney position is not a full-time employee of the City of Colby and shall not be entitled to benefits accorded to City employees. The City Attorney's duties shall include the following, to-wit:
  - Prosecute violations of city ordinances.
  - Give legal advice to city officials, Police and Fire Department employees and other city employees as authorized by the City Manager.
  - Prepare certain legal papers and documents as required which may include preparation of certain ordinances and resolutions.
  - Attend all regular Council meetings as requested; and, upon request, special Council meetings or board meetings as advisor.
- Representation, not included in normal service as above described, shall be authorized by the governing body of the City of Colby, Kansas. This representation is not part of the City Attorney's normal duties, and shall be billed at an hourly rate approved by the Governing Body. Such representation may include litigation, condemnation proceedings, jury trials above the Municipal Court level, and out-of-city legal services on behalf of the City of Colby.
- The City Attorney shall furnish a monthly accounting of the service provided under the monthly retainer and billed as additional representation.

Nothing herein shall prevent or limit the City Attorney from conducting his private practice or prevent the City of Colby from obtaining other counsel to represent it on specific matters or cases not included under the duties of the City Attorney.

SECTION 6. REPEALER. Ordinance No. 1419, dated February 20, 2007, is hereby repealed.

SECTION 7. This Ordinance shall be in full force and effect from and after its publication in the official city paper as provided by law.
