Colby College head men's basketball coach John Woods' possible swan song had much the same tune as his first 90 games on the

Trojan bench. Reduced to playing the role them from Region VI Tournament contention Saturday, the Trojans finished a disappointing season by losing for the 13th time in 14 games to Seward County 69-58 Sunday at the Colby Community Building.

Despite starting the conference season 2-0, the Trojans wound up 7-23 overall and 3-13 in the Jayhawk Conference.

"We had a lot of things that didn't go our way," said Woods. "The suspensions and injuries were out of my hands. That could have changed the outcome of our

Now, Woods and the rest of the team are in wait and see mode.

College President Dr. Lynn 18 points. Kreider and athletic director sign Tuesday. He declined and will continue his duties as the basketball coach until his future is decided at the college board meeting March 17.

"We just have to wait for the board to make their decision," said Woods. "I'm going to keep recruiting and working with the guys as if I plan on coming back.'

Just as unsure as the coaching situation is at the moment, the same is true of Woods' players.

After the game only one player out of four that were asked, Milos Bucalo, said he would definitely be back next year.

Among those still unsure of his future is Trojan guard Mike Boyd, who led the team in scoring at 18.8 points per game, but missed the fi-

nal five games with a leg injury. "I'm still undecided right now," said Boyd. "I need to talk to my mom. I might have to move closer to home, so she can see me play

Boyd hails from Baton Rouge, LA. Should he decide to stay, he says it would be tough to see his head coach lose his job, but under-

stands the nature of the business. "I guess they thought he wasn't doing his job, but I kinda feel like it's our fault too," said Boyd. "The season went bad and he didn't get enough wins, so they (the administration) has to do their job. I wish the best for him. Maybe if he finds another job, I might follow him."

With so much uncertainty surrounding the team, the one thing the Trojans were sure of is how much better they felt they were than their 7-23 record shows.

"Me, Drew (Andrew Engel) and Koance (Davis) only played four conference games together," said Boyd. "If we would have played together more, we would have won more games. If they had my 15 or 20 points, we would have won today."

"We're 10 times better than our record," said point guard Tashaun Kelly.

Nevertheless, the record books will show the Trojans at the bottom of the Western Divission for

The Trojans trailed by as many as 18 points in the first half. They rallied to get as close as five in the second half, but Seward was able to keep them at bay.

The Trojans shot only 34 percent for the game and 26 percent in the first half.
