## County settles lawsuit

A lawsuit against Thomas County and two of its employees has been settled out of court.

Colby resident Darrel E. Wark serves as trustee of the Mary L. Osborne Testamentary Trust.

Wark alleged chemicals applied at the county's direction on June 8, 2006, killed or damaged trees on property owned by the trust. The land on which the spraying was done consists of about 1,120 acres in the far northeast corner of Thomas County.

Defendants in the case are Kenneth F. Ptacek, Jon Selley, former Thomas County Commissioner Ron Evans, and current Commissioners Ken Christiansen and Paul Steele. Sowers was not on the board of commissioner at the time of the incident and is not part of the case.

"This settles it," Steele said. "We told them they could sue us, but that we were going to ask for our \$6,000 and we are going to get it. We are now out of the deal and we are getting paid."

Ptacek was noxious weed director at the time the incident took place and Selley worked with in the department with Ptacek. Selley is currently Assistant Noxious Weed Director, working along side Clair Schrock. who was not named in the case because he assumed the position after the time of the incident. Ptacek is employed by the county as a part-time seasonal worker.

Also named as a defendant is Frontier Ag Inc. of Oakley. Wark, on behalf of the Trust, continues his claim against Frontier Ag. Inc.

Wark believes the trees were killed or "severely damaged" when Frontier Ag sprayed over the late Osborne's land, according to court documents.

Great Bend attorney Allen G. Glendenning was assigned to represent the county and its employees by the county's insurance pool, KCAMP.

The money Steele referred to during the commission meeting on Wednesday when settlement agreement paperwork was signed is \$5,704.40 in unpaid taxes due on the property listed in the lawsuit.

As part of the agreement, the county's insurance carrier, KCAMP, will pay \$6,000 to the Mary L. Osborne Testementary Trust and the trust will pay its taxes making the settlement an almost dollar for dollar wash.

## Help with domestic violence increases

Providing people a safe haven during a crisis prompted two area agency workers to meet with Thomas County Commissioners recently.

Becky Bond and Michelle Morris, outreach advocates for the Northwest Kansas Domestic and Sexual Violence Services, Inc., talked to Commissioners Ken Christiansen, Paul Steele and Byron Sowers and asked them to renew funding for the Hays-based agency.

"We served 44 clients in Thomas County during 2006 and 67 clients in 2007," Bond said. "That's a 35 percent in-

The Northwest Kansas Domestic and Sexual Violence Services, Inc. serves Cheyenne, Rawlins, Decatur, Norton, Rooks, Osborne, Sherman, Thomas, Sheridan, Graham, Logan, Wallace, Logan, Gove, Ellis, Phillips, Russeell, Smith and Trego counties by providing safety and advocacy to abused people.

Based in Hays, the agency has two satellite offices, one in Colby and the other in Phillipsburg, all three of which offer services at no charge to abuse victims.

Steele asked Bond about a brochure she gave the commissioners on which it said the agency provides "legal, medical, financial and personal advocacy."

'We don't provide the legal meetings.

Bond said part of the service is to provide safe lodging.

There aretwo houses where people can be away from their abuser until more permanent residence is arranged.

She said the \$1,000 requested from the county assists with transportation from the 18 counties to a safer area for the indi-

"We use our safe houses up to 72 hours," Bond said.

"Then we transport them to our home in Hays, or if they have family in another state we'll help them get a bus ticket."

Thomas County budgeted \$1,000 in 2008 for the agency. That figure is part of a total agency budget of \$400,000, which stems from contributions from the 18 counties and cities within them of between \$10,000 and \$12,000 dollars per year, with the balance from state and federal grant money and private


The travel center and restaurant

"We are just finalizing things right now," Bosselman said. "I can't go into details about the franchise brand, but we are hoping to start building this summer. It will be a 60 room motel, part of Phase Two." As for another restaurant, Bosselman said that is coming in

"There's nothing concrete yet," he said. "But we are looking at something down the road. And we are looking at other developments such as a service shop. We don't know when, but it's on the plans and we don't have a timeline for that right now."
