




### Weather Corner

## Chapman residents return

CHAPMAN (AP) — Residents of this central Kansas town were sorting through debris and their frightening memories of a deadly tornado while areas to the east endured another round of spring storms.

The new storms brought rain and sparked fears that twisters would develop around communities such as Topeka and Emporia. The National Weather Service said several tornadoes were spotted in Chase County, but it had no reports of damage or injuries.

The twister that touched down Wednesday night in Chapman cut a path six blocks wide through much of the town of about 1,400 about 70 miles west of Topeka. It left one woman dead, reduced some houses and businesses to rubble and snapped utility poles and downed trees.

Officials estimated the damage at more than \$20 million and said the tornado heavily damaged or destroyed 65 buildings or homes, meaning between half to 60 percent of Chapman's buildings were hit.

Debby Peterson and her husband were caught outside on the edge of the tornado's path. They had left their house without a basement to go to a neighboring home and were standing on the back deck when the detached, two-car garage flew past them and into the back of the house.

"Then we hear this whooshing noise, and the trees are popping and cracking and all kinds of things," said Peterson, office manager for the Chapman & Enterprise News-Times.

# Mammoth tusk found in Norton County

Great trumpeting woolly mammoths right here in Norton County?

Well, maybe.

County road grader operator Herman Pfannenstiel was trying to repair a washed out road last Tuesday when he noticed something out of place so he called his boss, Road and Bridge Supervisor Tom Brannan telling him that he thought he had discovered human remains.

Mr. Brannan immediately contacted Sheriff Troy Thomson.

The call coming in about possible human remains caused quiet a bit of consternation in the office, the sheriff said.

However, when he and Mr. Brannan converged on the spot it was discovered that what looked like bones from the seat of a grader was actually a tusk.

"I got there and I said, 'I know what that is.'" Mr. Brannan said. "It's a mammoth tusk."

The tusk is about four-foot long and slightly curved, Mr. Brannan told the county commissioners on Monday.

The sheriff said that he called Sternberg Museum at Fort Hays State University and Dr. Richard J. Zakrzewski, chief curator of the museum, sent out a couple of graduate students to look at the find.

It took them about five minutes to say, yep, that's a mammoth tusk, the sheriff said.

Both Dr. Zakrzewski and the grad students were out of the office on Monday but the secretary said that the graduate students were excited about the find saying that it appeared to be in good condition.

The museum will excavate the area, the sheriff said, adding that the graduate students thought the entire animal could be found in the area.

The secretary at the paleontology department said that work would probably not begin for a week or so because the process has to be coordinated with the graduate students, a supervising paleontologist and the county.

The tusk is on the county right-of-way, Mr. Brannan said. However, the skeleton could be found on nearby private ground. Therefore, he said, the landowner has

tion starts the road will need to be closed. However, he said, it is a farm road and not used very often.

To protect the site, the artifact was reburied and the sheriff has the coordinates to the location.

# Former Oberlin business owner charged in fire

Arson charges were filed Friday against a co-owner of the Centennial Bowling Alley and the Red Crown Lounge, which burned down three years ago over Memorial Day weekend.

Sheriff Ken Badsy and Deputy Jay Tate arrested Ken Morgan of Oberlin on Friday on a warrant from the attorney general's office. Sheriff Badsy said Mr. Morgan made his first appearance before Judge John Bremer the same day and bond was set at \$100,000.

The defendant requested state-appointed counsel. That afternoon, David O. Baumgartner of Phillipsburg was appointed a Mr. Morgan's attorney.

The charges include two counts of arson, a level 7 nonperson felony.

The fire at the bowling alley and lounge, owned by Mr. Morgan and Maurice Zodrow, started around 3 a.m. on Monday, May 30, 2005.

After the Oberlin Fire Department extinguished the flames, Undersheriff Randy McHugh started an investigation.

Later that day, the crime scene was turned over to the state's fire marshal's office. Melvin Dale, an investigator sent out by the office from ???Garden City, went over the scene.

After nine hours checking out the scene, Mr. Dale declared the fire an arson.

The June 1, 2005, edition of *The Oberlin Herald* reported that, "Mr. Dale said he didn't find a source for an explosion (reported by witnesses), but it could simply

have come from the rapid buildup of heat in the fire.

"Flames and smoke were rolling out the west end of the bowling alley roof, over the kitchen, where the fire was most intense. There, the steel roof was warped and buckled. 'At this time, I'm going to call the fire arson,' the investigator said. 'As to how it was set, I'm not going to say at this time. I'll have to wait until tests are back from the lab.'"

At the beginning of 2006, Mr. Morgan and Mr. Zodrow filed a lawsuit against underwriters with Lloyd's of London who insured the building. The men were seeking \$300,000, the amount the building was insured for.

Later that year, court records showed statements from the insurance carrier that its defense

would be that the owners set or had someone set the fire. In April 2007, the lawsuit was dismissed after an out-of-court settlement.

At the time, Mr. Zodrow said the settlement wasn't enough to rebuild.

Original reports showed the damage near \$750,000. Mr. Zodrow said he wasn't allowed to say how much the co-owners received.

The suit was filed against Heritage Managing Agency Ltd., underwriters with Lloyd's of London, which is know for working with movie stars and the like to insure things like an actress's legs.

Mr. Morgan was still in the Decatur County Jail on Monday. Sheriff Badsy said he doesn't know of any other charges com-

ing in the case.

A preliminary hearing is scheduled for 10 a.m. on Monday, June 16.

Ashley Anstaett, spokesperson for Attorney General Robert Six, said the office is handling the case is because Decatur County Attorney Steve Hirsch referred it to them.

The reason it took three years to file charges, she said, is because the lawyer who was handling the case ended up leaving the office and it was transferred to another attorney, who had to get caught up.

Mrs. Anstaett said she couldn't comment on the evidence behind the arson charge. The attorney who filed the charges, Barry Disney, was in conference for two days and did not return a call.

## Oberlin, developer continue hotel talks

The Oberlin City Council talked with a Nebraska man interested in putting a 21-room motel in town at the meeting Thursday, but neither party made an offer.

Dave Winfield of Kearney, Neb., said his chain, Winfield Inn and Suites, focuses on small, rural towns because he likes the people. The motel would have cherry wood furniture and flat screen televisions in the rooms, he said, and the rooms are geared at families and couples in the 45-65 age range. The rates will be affordable, said Mr. Winfield.

The number of rooms can be adjusted, he said, adding that the motel would offer high-speed Internet and a continental breakfast.

The company is based in Kearney, where he owns a strip mall. Mr. Winfield said he is building

a 21-room motel in Curtis and a 10-room motel in Arnold. In the motel plans, he said, he tries to leave some land so he can add on later.

Mr. Winfield said he owns his own construction company and will do all of the work He told the council he always keeps his word,

so as long as the council does the same and is honest and up front with him, they will have a good working relationship.

Mr. Winfield said if he does end up building a motel here, it will be a nice, new place but he thought there probably won't be enough business for two motels.
