## Commissioners close township road

County commissioners on Thursday closed a road that lies within a piece of irrigated farm ground and are researching closing a road that criss-crosses farm ground.

Commissioner Ken Christiansen, Paul Steele and Byron Sowers approved Keith Baalman's request to close the northeast corner of a section of land which runs from U.S. 83 north to the Kyle Railroad west of Rexford.

The land is just north of McCarty Dairy and closing the road drew no opposition at a hearing that took place at 9 a.m. during the commission meeting.

In June when Baalman talked to the commissioners about closing the road, Christiansen said the road has not been used for "more than 50 years."

A petition for closing a road that was submitted by Sowers, acting in the capacity of taxpayer not commissioner, did draw opposition.

Sowers, along with his wife, Linda; James Dwight Sowers and his wife, Jeanette; Frank Howard and his wife, Betty, signed the petition to close part of County Road K.

The portion of the road they want to close runs between Section 7-9-31 and 12-9-32, extending north and terminating at County Road L, which is a portion of County Road 31.

road because the south fork of the Solomon River crosses it in an S-shape and it's difficult to fence," Sowers said.

Sowers said he has not seen anyone use the road in years.

Lonnie Wilson, who lives in North Randall, opposed closing the road.

"Marvin Albers said he has gone through there to save the three mile detour," Wilson said.

"Mr. Albers is not here today," Steele said. "He elected not to be here."

Landowner Terry Wendell also opposed closing the road. When Wendell started using profanity toward County Road and Bridge Supervisor Clair Schrock, Steele directed Wendell to cease derogatory statements, which he did.

Loren Guill, a member of the Menlo Township provided notes from an agreement drafted on March 29, 1954, about upkeep of the road in question.

The agreement was made between Menlo and North Randall Townships.

The commissioners asked County Appraiser Mary Cech for her opinion about the agreement and she said she would have to research it before offering an

opinion about its legality.

"As far as Menlo Township is concerned," Guill said. "We have no interest in that road."

Wilson told the commissioners if they closed the road they would be denying future business opportunities to companies that might want to drill for gas or oil, or landowners who might want to lease or sell land to wind farm operators.

"You guys can not predict the future," Wilson said.

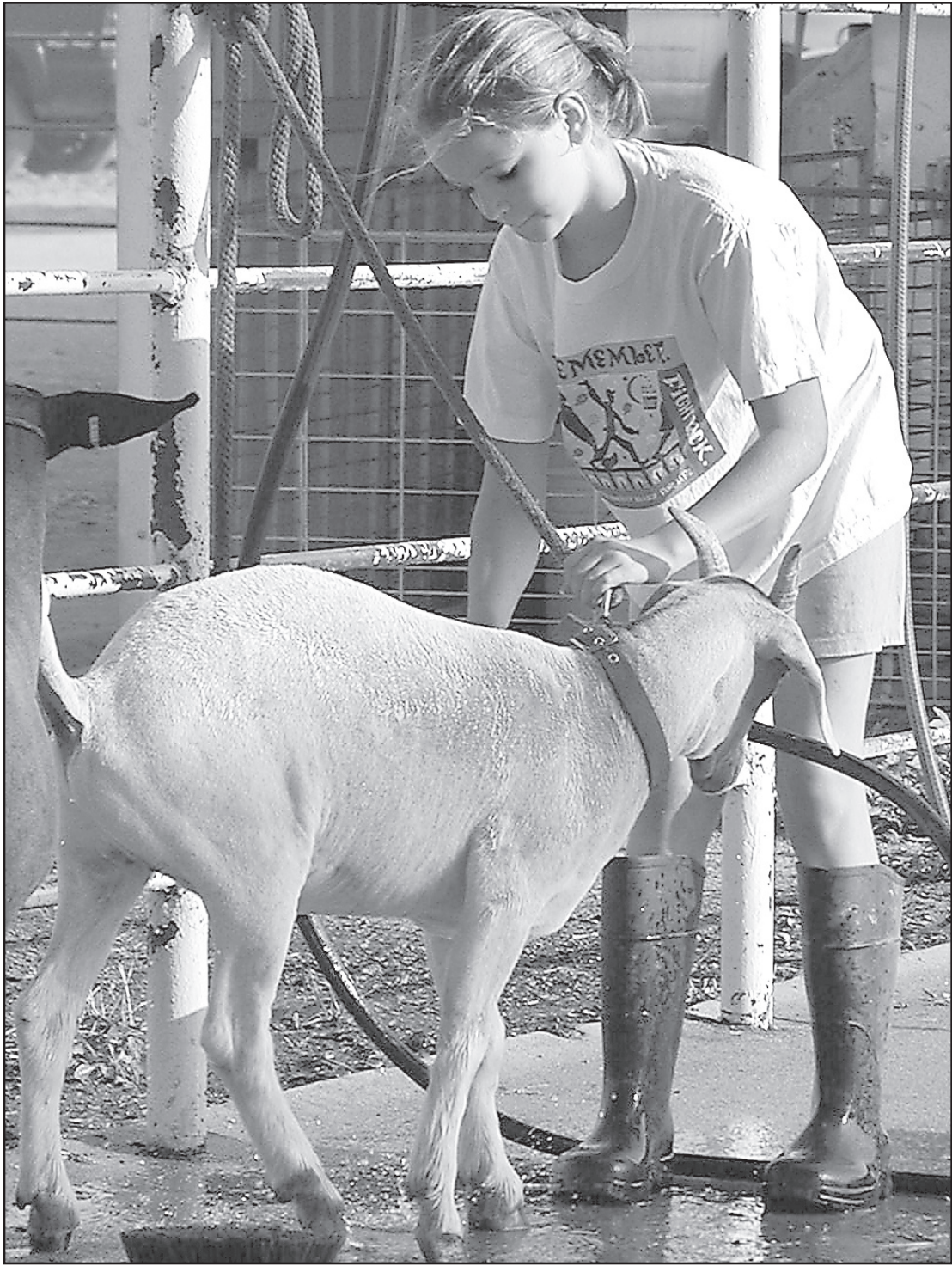
The commissioner have tabled closing the road until they meet Aug. 18.

In other business, the commissioners accepted a bid from Murphy Tractor of Ulysses for \$184,688 for a 644K wheel loader. The county has a guaranteed buy-back of the loader in the amount of \$125,000 after five years or 5,000 hours of use.

Payments on the loader will run \$11,933 per year, which was the lowest of four bids submitted. Other bid annual payments were \$20,673 from Martin Tractor of Colby, \$18,585 from Berry Tractor of Garden City, and \$18,000 per year from Van Koppel of Garden City.

All bids had guaranteed buy-backs.

## County divides health position

Thomas County Commissioners split the responsibilities of who will head up the public health department during their meeting Thursday.

Lisa Molstad had an exit interview as she left the job of administrator for Thomas County Public Health which is located in the county office complex at 350 S. Range in Colby.

Molstad left to live closer to her son in Florida. The exit interview was conducted behind closed doors and involved Commissioners Ken Christiansen, Paul Steele and Byron Sowers, and Molstad.

Following the 15 minute executive session, the commissioners conducted salary negotiations with Connie Walden, a Hoxie resident who for the past 10 years has

worked for Thomas County as a registered nurse.

Walden will assume the duties of clinic director and will oversee the medical side of the public health department.

Walden, who currently makes \$20.36 per hour, requested she be paid \$25 per hour, or \$52,000 per year, for the move to director. Steele told Walden the move to a co-director line-up, as well as hiring a second full-time registered nurse would push the budget to its maximum. Sowers said the change to the co-director status had to still work with the current, and upcoming 2009 budget.

"I have to live with the world that I have, not the world that I want," Steele said. "We are dealing with professional people and I want to give them respect for what they do and for the people that they deal with."

After about 30 minutes of negotiating, Walden agreed to work for \$45,000 per year starting today, Aug. 1. That figure works out to about \$3,750 per month, or \$22.77 per hour.

Walden thanked the commissioners for the promotion, and thanked Molstad for her service

with the public health department.

"I really want to thank her for all she brought to the department," Molstad said.

"She had a lot to deal with when she came and she did a good job."

While applications have been accepted and interviews conducted for someone to fill the slot of business director, no one has been hired. The commissioners on Thursday offered the job to one of the applicants at \$15 an hour, but it remains open due to lack of a response from the individual.

"The search is still on for someone for the business side," Christiansen said this morning.

Walden told the commissioners she will be on vacation from Aug. 6 to Aug. 13 and due to lack of staff the public health department will be closed during that timeframe.

"I think everyone will understand we are starting over," Christiansen said.

## Man killed when deer hits car windshield

SCOTT CITY — (AP) — A Scott City man was killed in western Kansas when a deer careened off another car and smashed through his windshield.

Thirty-one-year-old Jason Kanak died Wednesday night after a deer hit by another vehicle flew into the windshield of his pickup truck on Highway 4 in Scott

County. The State Highway Patrol says the deer went completely through the truck and out the back window. Kanak's wife, Lisa, was able to grab the steering wheel and

get the truck back onto the road after it swerved into a ditch. Lisa Kanak and the couple's 4-year-old son were taken to a Scott County hospital for possible injuries.
