Associated Press Writer DENVER – John McCain tapped little-known Alaska Gov. Sarah Palin to be his vice presidential running mate on Friday in a startling selection on the eve of the Republican National Convention.

Two senior campaign officials disclosed McCain's decision a few hours before the Republican presidential nominee-to-be and in speculation for months -

appeared at a rally in swing state former Massachusetts Gov. Mitt rience in foreign policy and de-Ohio.

Palin, a self-styled hockey mom and political reformer, has been governor of her state less than two years.

Her selection shocked many Republican officials. In making his pick, McCain passed over several more prominent prospects who had figured

his newly minted running mate Minnesota Gov. Tim Pawlenty, Obama's relative lack of expe- own party in a primary, then dis-Romney and former Pennsylvania Gov. Tom Ridge, among them.

At 44, Palin is a generation younger that Sen. Joseph Biden of Delaware, who is Barack Obama's running mate on the Democratic ticket.

She is three years Obama's junior, as well – and McCain has in December 2006 after ousting made much in recent weeks of an incumbent governor of her

Palin flew overnight to an airport in Ohio near Dayton, and even as she awaited her introduction, some aides said they had believed she was at home in Alaska.

A former mayor of Wasilla, she became governor of her state

Investigation continues in power-line accident

Officials of a power-line conaren't saying much about an accident Aug. 6 which killed one worker and injured two, but a federal agency says it's continuing it's investigation.

Jerrel C. Bingesser, 23, Council Grove, was killed and two other employees of PAR Electrical Contractors Inc. of Kansas City, Mo.,

were burned in an accident about Houston-based parent company of PAR, confirmed earlier this month that those injured in the electrical accident were a 42-year-old man Reba Reid, communications difrom Rossville and a 51-year-old from Reading. At that time, Reid rector with Quanta Services, the

said the cause of the accident was being investigated by the U.S. Occupational Safety and Health Administration.

Calls to Reid on Wednesday were not returned.

Judy Freeman, area director for the federal agency in Wichita, said the investigation is not yet done.

'We are investigating the accident," Freeman said, "but I have

nothing to release at this time.' Freeman said federal law gives her agency six months to complete the file on workplace accidents.

"If it is determined there was a violation of OSHA standards we'll issue a citation," Freeman said. "If there is no violations, the case will be closed."

She said once the investigation is done, the findings will become public. PAR says it is one of the largest outside electrical contracting companies in North America, with more than 2,500 employees. Quanta has 13,000 employees, with major offices in 40 states, and field and support offices in all 50 states and Canada.
