

Colby woman charged with battery

Michelle Dehart, 33, has been charged in Thomas County District Court with battery against Colby police officers Bobby Herron and Kevin Diercks. The two officers responded to a 911 call at 5:54 p.m. Monday, Sept. 25, from Slavens Family Clinic.

According to court documents, battery is a level nine person felony and Dehart faces five to 17 months in prison and a fine up to \$100,000 for each count. Dehart has also been charged with obstruction of official duty for her alleged intentional obstruction of Herron arresting her. A Class A nonperson misdemeanor, the charge carries a penalty of one year in the county jail and a fine of

Dehart is also charged with two Class B nonperson misdemeanors punishable by six months in the county jail and a fine of \$1,000 for allegedly refusing to leave the clinic when Herron ordered her to leave and then damaging a Colby Police Department car window when she did leave the building. Damage to the car window was less than

Dehart is also charged with disorderly conduct, a Class C misdemeanor punishable by one month in the county jail and a fine of \$500. This charge stems from Dehart allegedly being so noisy at the clinic she aroused alarm, anger or resentment in others present.

On probation for an incident which took place in Colby in April, Dehart is being detained in the Thomas County Jail as a result of the latest incident. In June, Dehart pleaded guilty to one count of criminal damage to property for damaging Michelle Schlegel's 1999 Pon-
