Socially disadvantaged farmers offered Farm Service Agency loans

The U.S. Department of Agriculture has money to or operating a farm and be unable to obtain credit lend women and members of minority groups who want to purchase or operate a family-size farm.

Dwight A. Jurey, farm loan manager for the U.S. Farm Service Agency for Logan, Thomas and Gove counties, said the agency can make farm operating and ownership loans.

"Each year," Jurey said, "the Farm Service Agency earmarks a portion of its farm-loan funding for socially disadvantaged applicants, people who have been subjected to racial, ethnic or gender inequality without regard to their individual qualities.'

This can include women, African Americans, American Indians, Hispanics, and others. Loan approval is neither automatic nor guaranteed.

"Socially disadvantaged applicants must meet the same eligibility criteria as other applicants," Jurey

Applicants must be citizens with a good credit hisfor the family at www.stewartfu- tory and education, training or experience managing

The agency can make direct loans to applicants unable to get commercial credit or provide loan guarantees to commercial lenders. Operating loans can be used to buy livestock,

equipment, feed, seed or pay other business related expenses. The repayment schedule is usually one to Ownership loans provide capital to purchase or enlarge a farm, construct or improve buildings, pro-

mote soil and water conservation and pay closing costs. Loan terms are up to 40 years. Last year, Jury said, the state obligated \$1.3 million for a total of 48 loans to qualified farmers un-

der the minority program and \$12.2 million for 198
