

## ORDINANCE NO. 1473

ORDINANCE **AMENDING** SECTION 7. **EXCESS POWER GENERATION** CREDIT ORDINANCE NO. 1464 OF THE CITY OF COLBY, PERTAINING TO **ESTABLISHING ELECTRIC SERVICE** 

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF COLBY, KANSAS:

#### SECTION 1.

Ordinance No. 1464, which establishes electric service rates for the City of Colby, was approved by the City Council on December 1, 2009.

#### SECTION 2.

SECTION 7. EXCESS POWER GENERATION CREDIT of Ordinance No. 1464 of the City of Colby is hereby repealed.

#### SECTION 3.

SECTION 7. EXCESS POWER GENERATION CREDIT of Ordinance No. 1464 of the City of Colby is hereby amended

Whenever any customer generates excess power (sold back to the City), a credit (reduction) shall be applied to the customer's bill. This adjustment shall be made each month, as dictated by the generation of excess power, and shall be computed based upon the City's average cost of purchased power for the preceding period. This will be calculated by dividing the City's total cost of power purchased, including transmission and all ancillary charges, by the number of kWh purchased in the period. The resultant rate per kWh will be applied to the number of excess kWh generated by the customer and, as mentioned previously, will result in a credit to their monthly bill.

#### SECTION 4.

This Ordinance shall take effect and be in force from and after its passage, approval, and publication as provided by law.
