SECTION 12. DOGS RUNNING AT LARGE

Defined below are two options that may be utilized in dealing with dogs running at large. The option selected is entirely at the discretion of the city.

- (a) Option 1: Impounding the Dog. The Enforcement officer of the City or other persons duly appointed by the City Governing Body, may take into custody and impound at a local kennel, any dog found running at large in the City contrary to this Ordinance. The owner will be notified and it will be their responsibility to get the dog, and pay any costs incurred from the kennel. If not claimed within seventytwo (72) hours, the dog shall be subject to disposal.
- (b) Option 2: Warnings & Tickets. The Enforcement officer of the City or other persons duly appointed by the City Governing Body may give two (2) warnings and then a ticket in lieu of impounding the dog (especially in cases where the dog cannot be caught). If the owners do not comply with the warnings, a ticket shall be issued and the owner subject to the penalties provided in this Ordinance. If possible, but not required, a picture of the dog will be sent to the owner, along with the warning or ticket.

SECTION 15. KENNEL LICENSES.

No person or household shall own or harbor more than four (4) dogs of six months of age or older, or more than one litter of pups, or engage in the commercial business of breeding, buying, selling, trading, training, or boarding dogs.
