Fall-planted seeds attract butterflies

feature to add to the garden to provide enjoyment all season long.

Butterfly gardens can be as much or as little work as you want them to be, said Jennifer Smith, a horticulturist with Kansas State University Research and Extension. Although a butterfly garden with a more cultivated look is possible, simply planting seed in the fall will create a low-maintenance garden with a wild look.

"A mix of annuals and perennials is a good choice to attract butterflies," Smith said. "Annuals tend to bloom over a longer period of time throughout the summer, so with them, you're more likely to have blooms that will attract butterflies season-long.

"Perennials, on the other hand, attract both butterflies and their larvae, and they're more likely to provide a food source for the larvae."

Smith suggested several flowers for a butterfly garden, including

A butterfly garden is a simple purple coneflower, cosmos, blackeyed susan, zinnia, petunia and phlox. Milkweed is important for larval food.

> Butterflies need water, Smith said, but they don't need the large amounts provided by a bird bath or sprinkler. She recommends placing rocks in shallow depressions throughout the garden. These will collect dew each morning and provide an adequate water source.

Smith said she recommends placing a butterfly garden in full sun.

"Butterflies depend on the sunlight to heat their body," she said. "Most of the annuals and perennials that bloom prolifically need full sun as well."

Tucking the garden away from the wind is important, though, Smith said. Butterflies find flying in a breeze difficult.

HEALTH PROGRAMS/ASSESSMENTS

All students up to the age of nine years enrolling in school for the first time in Kansas shall present official health assessment records showing evidence that the child has had a physical examination within twelve months of school entry. All new students MUST also have a copy of their birth certificate with them when they enroll.

All students entering school for the first time in Kansas must present official immunization records showing evidence that the child has been inoculated for the following: Diphtheria, whooping cough, tetanus, poliomyelitis, mumps, rubella and German measles. Hepatitis B vaccination is recommended for all students. Students who have not completed the required immunizations within 90 days after the beginning of school may be excluded from further attendance. Forms are available in the school nurse's office in the primary building. Further information may be obtained by calling the school nurse at 460-5111. (KSA 72-5209 et. seq.)

STUDENT ACCIDENT INSURANCE
