Texas storm reaches Colby on Thursday

A tropical storm that flooded parts of Texas and Oklahoma struck Thomas County a glancing blow Thursday, bringing low clouds, cool temperatures and light moisture.

Thomas County was on the very edge of clouds thrown out by Tropical Storm Hermine as it dissipated over Texas. Chris Schaffer, an intern with the National Weather Service in Goodland, said the storm was more intense in Oklahoma and Texas.

Schaffer had been monitoring the storm for the past several days in order to make aviation forecasts. The service's concern in this area, he said, was low visibility from the clouds or fog and high winds. Winds Thursday afternoon were still around 17 mph but tapering off. about 6 p.m.

Further south, several people were killed and more swept away as flash floods washed out roads. Storm damage knocked out the municipal water system in Holland, Texas, and rescuers had to pull more than 100 people from partially submerged cars across the state. The weather service reported winds blowing as fast as 137 mph.

According to the weather service, Hermine was first spotted as a tropical depression in the southwestern Gulf of Mexico early this week. It was given tropical storm status as it intensified on Monday. It was the eighth named storm of the 2010 hurricane season, but it never reached hurricane strength.

Hermine made landfall in northeast Mexico late Monday. It moved north into Texas the next day. It began to lose strength as

Transportation agency contracts e-mail virus

TOPEKA (AP) - The Kansas Department of an e-mail with the subject line, "here you have." Transportation says a computer virus forced a brief shutdown of its e-mail system.

The agency says the virus infected 55 of its 2,600 computers Thursday afternoon. All of the computers are expected to be operating normally by the end of the day Friday.

The department says the virus was spread through the subject line.

Clicking a link in the e-mail infected the computer, which then began sending e-mails to everyone on the recipient's contact list.

Thursday night, a prominent warning on the agency's website cautioned users not to open any e-mails from department contacts with "here you have" in

Commission release report cards for state judges up for retention

Earlier this month, a group of leased their recommendations on 53 Kansas judges up for retention on this year's ballot.

The Kansas Commission on Judicial Performance released their Justices are up for retention this recommendations on Sept. 1. The 13-member panel conducts surveys of lawyers, witnesses, victims and fellow judges for each judge on the ballot. Questions include whether or not the judge writes clear opinions, whether they render decisions without regard to possible criticism and their behavior in court. According to commission spokesman Randy Hearrell, the commission has surveyed more than 185,000 people.

For each judge, the commission gives an approval rating from judges and lawyers based off the surveys. They report the percentage of lawyers and judges who recommend retaining each judge and they give an average score out of 4, similar to a school grade average.

· Lawton Nuss received the lowest rating of the four from lawyers, 84 percent, and 92 percent from judges. Nuss was marked down particularly in categories of clarity and opinion writing, but praised for preparedness and demeanor while in court. Nuss, from Salina, is currently serving as chief justice after the death of Robert Davis in August.

There are also seven appeals chael Buser, Nancy Caplinger, Henry Green, Stephen Hill, Thomas Malone, Patrick McAnany and Melissa Standridge. The commission is recommending all these judges be retained.
