The Lady Trojans survived a sluggish start on their way to a 58-52 win over Hastings College's junior varsity team on Thursday in an Ambassador Classic game at the Community Building.

Freshman Liga Vente paced the Lady Trojans on offense with a team-high 18 points and 10 rebounds against the Lady Broncos from Nebraska. The 6'4" freshman hit a big fadeaway jumper in the lane that put Colby up 56-50 with less than a minute left. The bucket ended a 9-0 run by the Lady Broncos.

Sophomore Hannah Thornton, the Lady Trojans' other starting post player, added 16 points. Freshman Morgan Rickwartz chipped in eight points and had a team-high three steals.

Colby shot 44 percent from the field, but they made 61 percent of their shots in the second half. Colby out-rebounded their third straight opponent, grabbing 35 rebounds, 27 on defense, to Hastings 29.

The Lady Trojans struggled at putting the ball in the basket early in the game. They trailed 7-2 after the first 10 minutes of play.

The Lady Trojans went on a run early in the second half. Thornton got a friendly roll on a shot from the top of the key, tieing the game at 28. Moments later, a transition layup by sophomore Brooke Bursiek gave Colby a two-point lead.

Later, Vente grabbed a rebound and stuck it back in, giving the Lady Trojans a 44-33 lead. Colby stretched its lead to 52-39 before the Lady Broncos went on their 9-0 run, narrowing the gap to 54-50 with 1:02 left. Then Vente knocked down the fadeaway jumper. Hastings was unable to score on its next possession.

Thornton was fouled. She got to shoot a one-and-one because the Lady Trojans were already in the bonus. Teams get to shoot a oneand-one after the other team has committed seven or more fouls in a half. Thornton knocked down two free throws and the Lady Trojans went on to win 58-52.

With the win, the Lady Trojans improved to 2-1. They play tonight against Western Nebraska Community College from Scottsbluff in an Ambassador Classic game.
