## Walking trail gets \$25,000 donation

The proposed Colby walking trail took a giant step toward completion today with a \$25,000 donation.

Colby businessman Lon Frahm donated \$25,000 toward the creation of the first phase of the walking trail, which will be an eight-foot wide concrete path around the new aquatic center. Frahm also issued a challenge to the community: raise \$25,000 more by June 1 and he will match it for a total of \$75,000.

At a public meeting last Thursday, contractor Mike Woofster estimated the concrete for the Phase I loop would cost about \$75,000.

Frahm made the donation at a small ceremony this morning. Sue Evans of the Community Coalition said people can donate to the Thomas County Community Foundation, as long as they write "walking trail" in the check memo. Jada Tubbs, foundation president, said the foundation has set up a fund for the trail, which already has \$1,100 in it.

Mayor Gary Adrian, who was at the check-passing ceremony, took the opportunity to make a personal donation.

"It will add to the quality of Colby," he said. "There will be so many pluses with this park."

Ashley Moser, president of the Multipurpose Activity Center, said the trail could eventually connect with the center as well as the college and downtown Colby.

"This is the hub," Evans said. "Everything will go out from here."

Jeanene Brown of the Thomas County Wellness Committee said the committee has put up \$20,000 already for the trail. The city will be providing the land for the Phase I loops and the coalition has secured a \$24,145 grant from the Kansas Health Foundation for planning and additions such as a people counter and "exersite" — a series of exercise stations for children along the path.

Brown said the Wellness Committee has been pushing for the trail for more than 20 years.

## Colby College grad on trial in Norton

On Friday Ryan Zweygardt, made his first court appearance before Norton County District Magistrate Judge Debra Anderson.

Zweygardt, a Norton police officer and a Colby Community College graduate, was arrested last Thursday. He has been charged with two counts of first person felony of alleged rape, by force or fear. The charges were filed following an investigation by Norton County Sheriff's Department and the Kansas Bureau of Investigation.

Zweygardt has been a police officer in Norton since July 2010. He is a St. Francis native and graduated from St. Francis High School. He attended Colby Community College and received an associate's degree in criminal justice. Zweygardt had worked in law enforcement in Hays and at the Sherman County Sheriff's Office.

The charges are from incidents

that allegedly occurred on March 19 and April 10. Bail was set by statute at \$500,000.

In his first appearance, Zweygardt was given the opportunity to have the charges read to him along with his rights.

Judge Anderson went over the charges and explained that each count carries 147 to 165 months — 12 1/4 to 13 3/4 years — of imprisonment if found guilty.

"Do you understand the charges and the penalties if found guilty," asked Judge Anderson.

"Yes, ma'am," said Zweygardt.

Zweygardt's attorney, Dan Walter, presented a motion to the court concerning the officer's housing situation.

The Norton County Jail is under construction, making it impossible to segregate Zweygardt from other inmates. He is currently being held in Hill City at the Graham County Jail.

"There is no security issue at the present time and as there is

## State legislators resume budget talks

TOPEKA — Legislators returned to the Statehouse on Wednesday still searching for resolution over the 2012 Kansas budget.

The House and Senate passed competing versions of a \$14 billion budget before taking a three-week recess in early April. The plans outline how the state will fund schools, public safety and social services for the fiscal year beginning July 1.

While lawmakers agree in principle on the majority of areas where they would spend about \$6 billion in state tax revenues, differences remain over how deep to reduce aid to public schools, issuing new bonds to complete the Statehouse renovation and the future of the Kansas Arts Commission.

"We have an offer ready to go," said House Appropriations Committee Chairman Marc Rhoades. "My hope is we can meet a couple of times a day" until the budget's settled.

Rhoades, a Newton Republican, said he would like to meet privately with his Senate counterparts and leadership from both chambers to work out differences to expedite a resolution.

"I think the people of Kansas want us to get out of here," he said.

Senate Ways and Means Chairwoman Carolyn McGinn, a Sedgewick Republican and lead negotiator for the Senate, said she was ready to get to work, but didn't have an idea how long it would take the two sides to reach a final product.
