First with the building of our fabulous new aquatic center, the grade of the land was changed slightly in spots and new concerns arose that needed to be addressed. For these issues the architect had to visit and make recommendations and changes. Not something that happens over night.

Thus, water lines have to be run to the property and then on the property so that a sprinkler system for the grass and a drip system for the trees can be installed.

We also want a safe place for walking, day and night. That requires adequate lighting and thus the need for electric lines to be run.

All these things have to happen before we can start on the actual cement trails. Much of the work being done is volunteer and all this work has to be coordinated in the right order to make progress. This project would not be happening without all the volunteer work. I would recognize them now, but I might accidentally leave someone out so I will leave that for a future column. But if you are one of those volunteers, we want you to know we truly appreciate you and all you are doing!

Water lines are currently being run to the property. The Tree Board plans to begin planting trees around the property the end of October.

As for the actual walking trail, the goal is to start pouring cement for the first quarter mile of the trail the first part of November, weather permitting. We are moving into the time of year when our progress will be greatly determined by the weather.

The south entrance to the aquatic center has to be built before the south quarter mile of trail can be poured.

To qualify for a walking trail, the path must be between five and eight feet wide. This first half mile planned in the area by the aquatic center will be eight feet wide to allow for maximum comfort in use. Have you tried to walk beside someone down a four-foot sidewalk? My husband and I barely fit and if we meet someone we constantly have to slide behind one another. The eight-foot wide path death. will be great!

The Walking Trail committee continues to seek grant money to further the trail and the amenities along it.

We have plans for adding another two-mile trek. The Exercite equipment we are looking at will include adult and child friendly stops.

We are also looking at a creative and 13 grandchildren. play space that might include outdoor musical instruments such as mamba and kettle drums, xylophone, etc, large fabricated rocks to climb on and more. "Good things come to those who wait."
