### Seasons incidental when tornado comes to town

The February tornado outbreak points up a flaw in emergency planning for many Kansas counties: no one pays any attention to the sirens and other parts of the emergency warning system from November through February.

Most cities and counties wait until "tornado season" approaches in March before they test the sirens and put the system through its paces. That works fine. Most years.

And while it's true that the tiny Kansas town of Harveyville got no warning before it was hit because the tornado there literally dropped out of the sky, it requires a bunch of what-ifs to say that we don't need to worry about tornadoes in winter.

Nature, it seems, does not know about the "season" dates for her little productions. She sends out tornadoes when she darn well feels like it.

A huge tornado came over Colorado's Wolf Creek Pass a few years ago, laying waste to timber for miles and scaring the bejeebers out of some Texas elk hunters, who knew a twister when they saw one.

"Everyone" knew that none of that could happen: no tornadoes on the Continental Divide, no tornadoes in late October, no tornadoes in the Colorado high country. If it weren't for all those broken trees, people might have thought those hunters were imagining things.

Then a few years ago, a tornado west of Hays damaged houses in November, barely a week before Thanksgiving.

It's common to have tornadoes in the South in winter months. Storms that bring blizzards to the plains and ski weather to the mountains generate thunderstorms in warmer states.

But in Kansas?

So here's the deal. Why not just test the tornado warning system the first Monday of every month?

The first test of March, just before Severe Weather Week, usually turns up a few sirens that stopped working over the winter. Why wait? Tornadoes don't know about Severe Weather Week.


There's no harm in cranking up the publicity in March, but weird as our weather can be, why take chances with the sirens? Why not be ready? – Steve Haynes

than three years later, his inaugural words fail to match his actions and those of his administration.

President Obama gave America a preview of his warpath against organized religion and people of faith when he undid parts of an executive order by President George W. Bush protecting health-care providers from being required to perform, participate in or provide a medical procedure with which they had religious or moral objection.

But in the past month alone the Obama Administration has gone guns-a-blazing, fullforce against both religion and the Constitution.

First, President Obama and his "Catholic" secretary of health and human services, Kathleen Sebelius, finalized a rule that will require Catholic employers to cover and pay for contraception - including abortion drugs – and sterilization. The fact that the Catholic teaching excludes artificial contraception or abortion matters not a single bit to President Obama.

The Department of Health and Human Services argued that a one-year exemption is all religious organizations need in order to comply with this law. What President Obama and Secretary Sebelius do not get is that religious



organizations and people of faith do not need time to renounce their faith; they need their views to be protected by the First Amendment

Second, President Obama's Secretary of the Army - a political appointee - silenced Catholic chaplains from speaking out against this rule attacking religious freedom. If you are Catholic, you heard in your Sunday Mass a message from your bishop that "We cannot – we will not - comply with this unjust law." But not if you were serving in the military, defending the freedoms of other Americans.

Instead, the Army's Office of the Chief of Chaplains attempted to censor the reading of the letter from Archbishop of Military Services Timothy Broglio. After a conversation between Archbishop Broglio and Army Secretary John McHugh, it was decided that line would be eliminated.

Non-Catholics, those not in the military, and even those who support the use of abortion drugs and contraception should take offense at and be outraged by the actions of the Obama Administration. It could just as easily be something other than sterilization or abortion drugs next time. This rule requiring reli-


Sebelius" fig leaf. The widely reported press conference "accommodation" does nothing to respect the religious liberties of employers.

After proclaiming an economic fallacy - that the costs would be magically paid by someone else other than the employer - Sebelius and Obama finalized the rule without any actual changes. More empty rhetorical gestures – more attacks on religious liberty.

President Obama and Secretary Sebelius are receiving the backlash they are due for this reckless, errant and unconstitutional requirement being forced upon the country. The administration is paying only lip service to the First Amendment concerns of many Americans. To finalize the rule without protecting people of faith shows just how out of touch they are with the American people. But, perhaps more concerning is that their rule shows how selective they are with protecting the rights of Americans.

And, for that, the Obama Administration is an abomination.
