"The Cold Weather Rule helps to ensure that Kansans can be warm in their home this winter." said commission Chairman Mark Sievers. Consumers are encouraged to take steps to prepare for colder temperatures this winter."

Under the rule, utility companies are prohibited from disconnecting a customer's service when temperatures are forecast to be at or below 35 degrees over the next 24 hours and cannot initiate dis- on heating costs."

Customers must contact their utility company and inform that they cannot pay their bill in full, and then agree to pay 1/12th of the total amount owed, 1/12th of the current bill, the full amount of any disconnection or reconnection fee, plus any applicable deposit to the utility. They must agree to pay the remaining balance in equal payments over the next 11 months, in addition to their current monthly
