City to regulate heights

An Airport Airspace Protection Committee was formed to work on it. That effort ran into controversy in August, after Acciona, a Spanish energy company, questioned some provisions. The firm plans a wind farm with 36 turbines about five miles south of town, 14 of which would have been within the 50,000-foot corridors for the airport.

Ostmeyer said he did not have maps of the wind farm, so he could not confirm if those were the instrument procedure approaches, but thought only one or two turbines would have had an effect on the airport.

Peter Kennon and Lars Dorr, representatives of Acciona, protested the proposed ordinance during a heated discussion at the second airspace protection committee meeting Aug. 7. The committee voted to disband for lack of support at the end of that meeting, which was attended by about 20 landowners and community members, along with Ostmeyer and Brad Weisenburger, a consultant hired to help with the ordinance.

Acciona was not subject to any airspace ordinance at the time, but still agreed to lower the height of its proposed turbines from 584 to 518 feet after hearing they could interfere with the approaches to the airport, Kennon and Dorr pointed out. The federal agency had returned a "determination of no hazard" on the 7460 form Acciona submitted for the higher design, they added, and the they expressed confidence they would get the same designation for the shorter turbines.

Kennon and Dorr went to a City Council meeting the same night and asked the city to promise not to interfere with the wind farm as long as the towers were given a "no hazard" designation. They said 427 jobs could be created and \$21.1 million put into the economy in and around Colby during construction of the turbines. The council was unwilling to make that promise, however, and instead told City Attorney John Gatz to work out an agreement with the firm.

"We had to basically re-group and start over," Ostmeyer said.

Towers can alter the ap-

proaches to the airport by raising the safe height a pilot can fly when coming in, he said, and the federal agency does nothing to keep approaches open.

"It all boils down to one thing," Ostmeyer said. "It's our responsibility to protect our airport."

The airport manager said he had Jesse Romo with the Kansas Department of Transportation drive out to the next council meeting to warn the city that, while one branch of the FAA issues the "no hazard" determinations, another determines whether an approach to the airport has been compromised. That second branch could potentially pull the airport's eligibility for grants if it determines the approaches have not been kept open, Romo said, and the two do not communicate that well.

"He explained exactly what I was trying to explain," Ostmeyer said. "Sometimes it works better for someone to come from outside ..."

He added that the government provides the airport with \$150,000 a year, and pays 90 percent of the cost of projects.

out-of-district students to take them.

Since some certificate programs take only one or two years, she said, so students could complete them before they graduate from high school.

Clark-Leiker added that students from other schools, or home-school students, could come to Colby High part of the week.

"Here's Colby Community College sitting in our community with us," she said. "Colby High School is now a hub."

Making the high school a hub, she added, is a dream for her, and she hopes some day the school

could have a building on campus with rooms for colleges to use as classrooms. Clark-Leiker said Northwest Tech could use the high school as a place for students working on Central Time to take classes, and suggested that schools as far away as Pratt Community College would be interested in setting up shop here.

"As I have said for many years, I want (Colby High) to be the star of northwest Kansas," she said.

Asked if the school would get extra money, Clark-Leiker replied that it is possible for any students who take classes at the high school to be enrolled there, which could bring extra state money.

Man testifies about being shot in the right eye

Cokes," with an ounce of Crown Royal whiskey each, when he decided to go visit Phillip Collins. He said he drove his three-wheeler about five miles to the house, where David Collins pulled up behind him in a white Ford F-150 pickup.

Collins was telling him that his father was not home, he said, and he shut the three-wheeler off and got off so he could hear, when Collins shot him.

"All I know is there was a gun pulled out and he shot," Bowles said. "I just seen him pull a gun out of the truck."

He said that he was about four or five feet from Collins, who never left the truck, when he was shot. He added that after shooting him, Collins asked him if he needed a ride.

"I was like, 'You shot me,'" Bowles said.

He said Collins then drove off. "I sat there and scavenged

around a little bit so I could see better," he said.

After being shot, he testified, he sensed a ringing inside his head near his right eye. He got back on his three-wheeler and drove to his house with his hand over the eye, called his mother and started drinking whiskey out of the bottle.

His mother showed up 10 to 15 minutes later with Shellito, who told him he needed to go to the hospital. He said he spent about 35 to 45 minutes at the Logan County Hospital before being sent to Wichita for treatment.

Shellito testified later that Bowles had a bullet wound in his right eye and an exit wound near the right ear. Bowles said he still cannot see out of that eye.

In his cross-examination, Rork first established that Bowles had blood alcohol tests taken both in Logan County and Wichita, and asked that those be turned over as evidence.

Rork then questioned Bowles'

account of his encounter with Collins, asking if he recalled getting into an argument right before the shooting.

"He said something that Phillip wasn't there," Bowles replied, "and I was going to ask him when he was coming back and then I was going to go."

"And did he not ask you to go home because you were drunk?" Rork asked him.

Bowles said he didn't recall threatening or arguing with Collins, and added that he himself was unarmed.

"I understand you were unarmed, but you don't recall yelling or threatening David?" Rork asked.

Bowles said he did not recall having been told never to go to the house unless Phillip was home. He said he had not called Phillip before going to the house, and did not call 911 or the hospital after the shooting.

The sheriff's deputy, Shellito, testified that he got a call about

the shooting from Sheriff Pat Parsons about 3:30 p.m. March 5. He went to Bowles' house and was met at the door by Bowles mother, then took pictures of Bowles' wounds.

Shellito said his next stop was Phillip Collins' house, where he spotted a helmet and bloody pair of sunglasses. He said David Collins pulled up in front of his patrol car, and he asked him where the gun was. Collins gave him a black, double-action .22-caliber revolver. After his arrested, he said, Collins told him that he got in an argument with Bowles, who grabbed him, and that he pulled the gun out to scare him.

Collins told him the gun went off, adding that he may have tensed up and accidentally pulled the trigger too far. Shellito said that he could not smell alcohol on Collins' breath.
