Media bias shown in 'shutdown' hype

It's fascinating, watching the world - the Democrats and their hand-fed national media – blame the Republicans and the Tea Party for the impending government shutdown.

Social Security and Medicare applications, for instance, apparently will halt. National Parks will close, the Smithsonian will But will we really miss the government for a few days, or

even a few weeks? The effects will be hyped, but what's the The government shut down several times under President

Ronald Reagan, and no one seemed to notice. Two shutdowns prompted by Speaker Gingrich during battles with President Clinton turned the tide, as the president won the propaganda war and put all the blame on the Republicans.

Those longer shutdowns set the stage for this year's budget battle, entwined as it is with the drive to repeal or block Obam-

It seems the Republicans have every right to campaign against the health-care law and its possible consequences for businesses and the economy. Potentially huge costs frighten small-business owners and put a damper on already-slow job

At this point, though, unless they win some major concessions from Mr. Obama, the Republicans appear likely to lose the propaganda war and the political battle. The president says he's not about to give up on what he sees as his greatest accomplishment.

Cooler heads might advise the GOP to back off and wait for

a better shot, but of course, that may not come. It's the president who's refusing to negotiate right now, but



Prisoner finds flaws in jail

To the Editor:

I read you paper everyday and I feel like the Thomas County Sheriff's Office needs to be looked at for unlawful and illegal activity. I am not from here, and where I come from, the police are respectful and actually abide by the law.

There is not even a law library here where we can research exactly what we are accused

I am sitting in jail because my friend is accused of going 3 mph above the speed limit! That is not even a moving violation in Kansas, but the dirtiest part of this story is the way the police force themselves into people's vehicles.

They gave my friend who was driving a warning and walked after they said he was free to go, then they came back, reapproached the vehicle and ask if there were any weapons, bombs, drugs or large amounts of cash in it.

they ask if they can search the vehicle. If you deny the search, they call in a dog unit. And they will walk the dog around the car and say the dog got a hit in the back of the car, where it is not visible for you to see.

No matter what you say, they find a way into your vehicle and a way to pull you out and search you. More than half of the people who walk in (to the Thomas County Jail) tell the

All the cops are doing this little trick to get their way. I have been here since June 30 and have not been able to contact my family or to communicate with anyone because they took my phone and my emergency contacts. I was due for surgery in Denver, and they didn't even care. I've written about 15 grievances and not one response.

My leg is bleeding from a gunshot wound and not a thing has been done. I could catch an infection and they do not even give me my orthopedic shoes prescribed to me by my sur-If you say "no," as any normal person would, geon. But if I could tell the people of Colby

anything, I would want them to be aware of this setup that the police are doing. When the officer gives you a ticket or warn-

ing, just drive away and ignore him if he reapproaches the vehicle. This amounts to illegal search and seizure. They are profiling people and forcing their way into people's vehicles. Do not fall for it, people, because I sit here unable to get out and the county attorney will not agree to my release because I am not from

It is unfair what is going on, and every day they get away with it. Please warn the public. I am a professional tattoo artist from Denver. I made a drawing for you guys I thought you might like but I am not allowed to send it for some odd reason.

If you need info or details, I can provide actual legal documents to prove my accusations. I do not want to say names due to the treatment I already receive, but I would appreciate it if you made an article about it. Thanks again for hearing me out.

Editor's note: The Thomas County Sheriff's Office declined to comment on the specific allegations contained in this letter. But Undersheriff Marc Finley stated all inmate medical issues are treated immediately, and officers perform traffic stops and searches within legal guidelines.
