Alison Nordin and Preston Crumbaker are to be married Sept. 22 at Evangel Temple Assemblies of God Church in Kansas City, Mo.

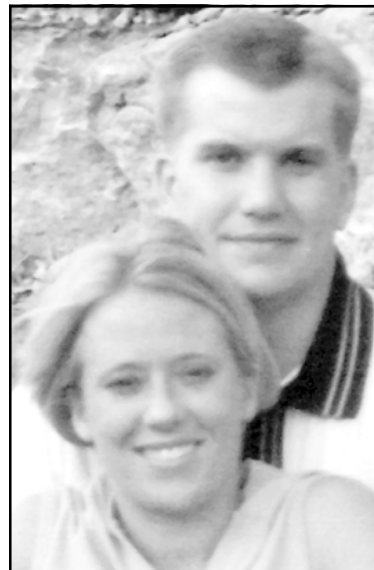
Parents of the bride-to-be are Doug and LaDon Nordin of Willmar, Minn.
