# Wichita wants to change 'dusty' image

The Wichita Eagle on tourism:

The Wichita City Council is trying to get the County Commission to join in a \$250,000 partnership to promote tourism. Part of the city's pitch, city marketing official Jessica Johnson told the commission ... is to move Wichita's image away from "dusty trails."

We understand that commissioners really mean we shouldn't try to hide from our Old West heritage, that it can and should be used to draw tourists....

But enough with "flat and dusty."

We can get more tourists. We should. Let's use all our attractions to

- ... Let's talk about our place as the general aviation capital of the world - there's no doubt about it — and about our absolute and total failure to exploit that.
- ... Let's talk about finishing the deal with downtown revitalization — and restoring jewels such as the Orpheum Theater...
- ... Lots of places are flatter and dustier than Wichita. Let them sell those, uh, virtues.

Good old common-sense Kansas, which by rights should be a leader on this issue, is about to fall one more state behind the curve of bringing sanity to the War on Drugs.

A drug-reform organization bankrolled by three of the richest people around ... has picked Florida as the next target in the campaign to recognize drug addiction as the illness it is, and create a new way of dealing with first- and second-time possession defendants.

Well, new in Florida. But not new in California and Arizona, where the drug court idea has caught on and is saving lives of addicts, and saving tons of taxpayers' money.

Kansas, apparently, is not yet on the radar screen of this campaign. ... Public officials, hopelessly addicted to the anti-drug drug and scared to death to appear as anything other than tough on crime, won't

... First- and second-time offenders don't go to criminal courts. They go to drug court. They are ordered, basically, to clean up, and connected with the counseling and other resources to do so.

... This idea makes so much sense the only thing standing in the way of it sweeping the nation is the paranoia, denial and other anti-drug drug symptoms that describe our elected officials.

It would be so wonderful if Kansas politicians would see the light and implement such a system here, without the need for the people to rise up and demand it.



# Look out for a new spin on an old fraud

Dear Kansas Consumers:

For several years my Consumer Protection division has been warning Kansas consumers to be aware of the "Nigerian Scam." The scam comes in the form of a letter promising millions of dollars in return for the use of a recipient's bank account. It started many years ago in Europe and more recently made its way to the United States. In Kansas, the letters first were addressed to businesses and some farm owners and ranchers who used a corporate name. Eventually the scam spread so that any Kansan could be a recipient of this letter. We used to tell consumers to be on the lookout for any letter that came from Lagos, Nigeria. We have now become aware of letters from other countries as well. Therefore, we want to warn consumers to be wary of any letter that comes from any country bearing the following traits.

The sender of the letter claims to be a civil servant who wants to transfer millions of dollars out of his country. He claims that, as a civil servant, he is forbidden by protocol to own or operate a foreign account, so he proposes to give 30 percent of \$35.5 million to the recipient's bank account. According to the letter, he and his associates will keep 60 percent and the remaining 10 percent will be used for expenses such as bribes for officials who are not involved in the deal. To receive this cash windfall, the recipient is asked to send his or her banker's name, telephone and fax numbers,

back account number and a blank sheet of business stationery signed by the recipient.

Please be aware that this is a scam to obtain your banking information which will allow the sender to access your account and steal your money!

Once again, we encourage Kansans to ignore these letters in spite of the temptation for tremendous wealth. If you respond to the letter, you will receive a follow-up letter or fax that asks for an advance fee, a transfer tax, a performance bond or some form of up-front payment. If you pay the money, further "complications" requiring more money will arise until you have had enough, run out of money, or both. The scam artist may even take a more direct route and wipe out your bank account electronically. This is why you should never give out your bank account number.

Do not allow yourself to become a victim. If you receive a letter from any African country that resembles this scam, but have not suffered financial damage, fax the documents to the Secret Service Task Force at 202-435-5031. If you have suffered

financial loss, call 202-435-5490 and leave a telephone number where an agent can reach you. You may also mail the letter to: United States Secret Service

It is estimated that the scam has netted about \$5 billion worldwide. It is virtually impossible to recover any losses, so it obviously has devastating effects on victims. Please be careful not to become one of them.
