Monday, Aug. 26, 2002, at the Goodland Good Samaritan Center where she had been a resident for the past four years.


She was born on July 3, 1922, in


daughter of Harry D. and C. Grace (Kime) White. She and her family moved to Sherman County when she was a little girl, and she attended school and graduated in Goodland.

She was a member of the Wesleyan Church and of the Veterans of Foreign Wars auxiliary and the After-5 Club, affiliated with Christian Business and






