ORDINANCE NO. 1579

AN ORDINANCE ESTABLISHING PROHIBITIONS AGAINST THE POSSESSION OR CARRYING OF CERTAIN FIREARMS WHILE UPON DESIGNATED PROPERTY OWNED AND/OR OPERATED BY THE CITY OF GOODLAND, KANSAS, AND AMENDING 12-203 OF THE CODE OF THE CITY OF GOODLAND, KANSAS.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF GOODLAND, KANSAS:

SECTION 1. Section 12-203 (4), (5), (6), and (7) of the Code of the City of Goodland, Kansas, is hereby amended to read as follows:

(4) Pursuant to the authority granted to property owners and to the owners or operators of businesses under K.S.A. 2006 Supp. 75-7C11, as amended by Section 6 of Chapter 166 of the 2007 Session Laws of the State of Kansas the governing body of the City of Goodland, Kansas, hereby prohibits the carrying of any concealed firearms by any person other than those identified in Section 5 below while in or upon the premises of any of the following buildings which are owned by the City of Goodland, Kansas, and/or on which the City is operating as a public employer:

- 1) The Goodland Fire Department located at 204 W 11th in Goodland, Kansas;
- 2) The City of Goodland Wastewater Treatment Plant located at 1929 N Caldwell in Goodland, Kansas;
- 3) The City of Goodland Public Works located at 17th and Arcade in Goodland, Kansas;
- 4) The City of Goodland Power Plant located at 1701 Cherry in Goodland, Kansas;
- 5) The bathhouse at the City of Goodland Swimming Pool in the City of Goodland, Kansas;
- 6) The City of Goodland Public Transportation Van within the City of Goodland, Kansas;
- 7) The High Plains Museum located at 1717 Cherry in Goodland, Kansas;
- 8) The buildings located at the Goodland Municipal Airport located at 596 Airport Road in Goodland, Kansas;
- 9) Any other city owned buildings within the corporate city limits of Goodland

(5) Violation of Subsection 4 of this ordinance is a Class B Misdemeanor.

(6) The prohibitions set forth in Section 2 above shall apply both to the interiors of the structures on all such properties; provided, however, that the prohibitions shall not apply to persons who are otherwise lawfully in possession of any such firearm while in a motor vehicle which is located in the area designated for public vehicular traffic or for public vehicular parking.

(7) The prohibitions set forth in subsection 2 4 above shall not apply to any person identified under the exclusions set forth in subsections (b) or (c) of K.S.A. 21-4201 regarding the criminal use of weapons, as said provisions now apply or may hereafter be amended.

SECTION 2. This ordinance shall take effect and be in force from and after its publication in the Goodland Star News.
