## PUBLIC HEARING NOTICE

Sherman County will hold a public hearing on Friday, September 28, 2007, at 8:30 a.m. (MT) in the Commissioners Room of the Sherman County Courthouse, 813 Broadway, Goodland, Kansas, for the purpose of considering an application to be submitted to the Kansas Department of Commerce for Small Cities Community Development Block Grant funds under the Community Facilities category. A specific project application to be discussed is the acquisition of a quick attack brush fire truck with necessary equipment for the Sherman County Rural Fire District #1, in an area generally bounded by the service area of Station 1 of the Sherman County Rural Fire District #1. A service area map can be viewed at the Sherman County Clerk's office. The estimated total project cost is \$122,950 with the grant request for \$92,212 of the project cost. Other proposals introduced at the hearing will be considered. Oral and written comments will be recorded and become a part of Sherman County's CDBG Citizen Participation Plan.

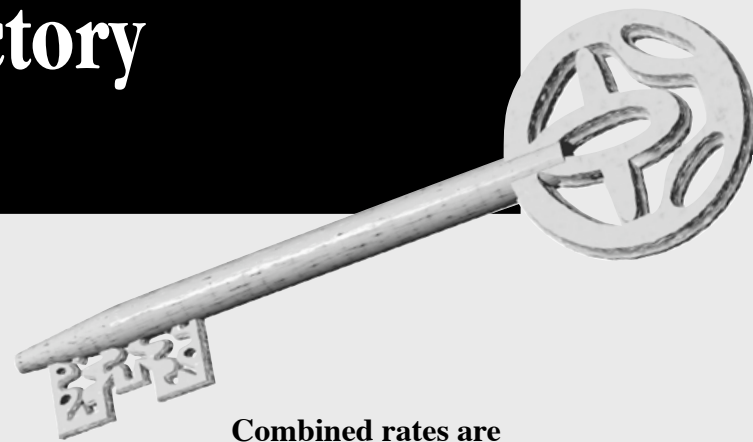
