Races for the 18th annual Flatlander Fall Classic will give fans more than 12 hours of high-speed action Friday and Saturday on the dirt track at the Sherman County Speedway. Races on Friday begin at 6:30 p.m. and at 5:30 p.m. on Saturday.

Alex West, president of the Sherman County Racing Association, said on Friday the cars in the mini stock, econo, bomber, stock and modified classes will run in qualifying heats to determine starting order for the main events on Saturday.

Those will be tabulated at the end of each performance, then compiled at the end of each category to determine first, second and third place

Winners will be announced and Flatlander Picnic in the Park, Johnson said. Prizes will be \$100 for first, \$50 for second and \$25 for third in

#### each category.

All three first-place winners will perform at the picnic before the headliner, the Pieces of Eight band. Johnson said he is the lead guitarist for the band, which includes Andrew Melia on drums and vocals, Howard Culver on bass and vocals and Heather Hays as the lead singer.
