she said, a patient shouldn't eat anything for 12 to 14 hours to be sure the cholesterol

The hospital's laboratory will produce the profiles, which will be available the day of the health fair for review with one of the Goodland Family Health Center doctors. Results can also be mailed by making arrangements at the time of the blood draw.

Free screenings at the fair include lead, cancer and carotid artery. The lead screening can be done with a finger prick on anyone 6 months or older. Members from the Kansas Healthy Homes and Lead Hazard Prevention Program will conduct the tests and answer questions about lead hazards

Doctors from the University of Kansas Cancer Center will conduct cancer screenings at the fair. Two urologists will offer digital rectal screenings for prostate cancer, which in combination with a prostate specific antigen test (offered for \$15 extra with the blood profile), is considered the best method of early detection.

Aderma-scan, showing sun damage, and a bone density screening will be offered as well. The cancer center will also distribute materials explaining the screenings and other issues, including breast cancer early detection and colorectal self-screening.

The hospital will try to offer it again at the next health fair, she added.

the Buffalo Guys, asked Moran if he could do anything about the fact that for buffalo the USDA inspects the meat at slaughter and again at each of the different processing steps, such as grinding or making into jerky. Moran said he would like more information and Klemm said he would send him some.

"The No. 1 domestic issue will be the cost of health care," he said.

Goodland Regional Medical Center Administrator Jay Jolly said that the hospital is having problems getting ambulance bills paid for the ambulances based in Kanorado and Brewster. Jolly said Medicare won't pay a set fee because the ambulances are making runs of less than 35 miles.
