Salary set for newly appointed register of deeds

Tuesday with Billie Hoyt, nominated by the Republican county committee to be the new register of deeds, and set her salary.

The commissioners held a closed-door session with Hoyt to discuss personnel matters for the register of deeds office.

After the session, Commissioner Mitch Tiede asked the other commissioners what they should set as her salary, as she will no longer be an hourly employee.

Commissioner Chuck Thomas said Hoyt has been working in the office for 11 years. and he felt they should start her out at a higher rate. Commissioner Kevin Rasure said he agreed and suggested a starting pay

Tiede said that made sense since Hoyt said she is not planning to hire a deputy but wants to try to do everything herself.

County Clerk Janet Rumpel asked when the salary would begin. She said Hoyt is waiting for approval of her appointment

Tiede asked Crystal Wright, county payroll clerk, about how to switch Hoyt from hourly to salary. Thomas asked if the county has to wait for the official appointment, suggesting they could go back to the beginning of the pay period. Rumpel said Hoyt began doing the job full time on Jan. 1.

Wright said the employees have been paid through Jan. 4, and the next pay checks will be issued on Jan. 28. Rasure suggested starting Hoyt's salary on Jan. 5. With the agreement of the other commissioners, Wright said that would work.

Another question Wright raised was the unpaid vacation on the books for Hoyt. Rumpel said that time is probably due and should be paid. Thomas said he did not understand why the vacation should be paid. Rumpel said that an elected official does

not accrue vacation time.

a day off two weeks ago. He also had two personal days he could use and said he should have checked "personal day" on his time sheet but checked "vacation" instead. He got a call from the clerk's office telling him he isn't allowed to use his vacation until he is on the job at least six months. It was just a mistake, he said, but it has been turned into a big deal.

The resolution forming the council states that it has the power to "recommend employees, supervise, evaluate and dismiss staff, including the setting of requisite qualifications, duties and compensation for staff and to establish personnel policies, subject to minimum compliance with personnel policies of Sherman County and final approval of the Sherman County commissioners."

The resolution also says the council has the power to "negotiate and acquire, through rent, purchase or donation, real and personal property... subject to final approval of the commission."

"We can't call the county for approval every time we send someone out of town," said Newell.

"When you get a purchase order, it's a surprise then," he said, "or it's a surprise when you get

Daniels expressed concern that the council's hands would be tied by having to ask the county before buying anything.

Some board members ques- he has gotten from the county clerk's office have been about little things that were blown out of proportion.

"An audit once a year — I can understand that," he said, "but these calls that we bought three stamps at the post office instead of from the county, that's petty."

Dobbs and Jennings are county employees, and they need to go along with county policies, said board member Jerry Fairbanks there's no question about that. But maybe the policy needs to be changed, putting dollar limits on this, he said, instead of the county approving all purchases.

The bookkeepers have the problem, Tiede said; they read the policy to the letter, but that's their job. Tiede felt if the council would file purchase orders with the clerk's office and if economic development staff would adhere to the employee policies, including vacation pay, that would solve the

"If you could do these few things to quit ruffling the feathers," Tiede said, "I think it would be fine."
