Notice Concerning Proposed Kansas Air Quality **Construction Permit and Public Hearing**

Notice is hereby given that the Kansas Department of Health and Environment (KDHE) is soliciting comments regarding a proposed air quality construction permit. Goodland Energy Resources, L.L.C. (GER) has applied for a modification to their existing air quality construction permit in accordance with the provisions of K.A.R. 28-19-300 to modify the proposed emissions reduction system and expand the types of fuel burned at its facility located west of Goodland, Kansas. Emissions of particulate matter (PM), PM equal to or less than 10 microns in diameter (PM10), volatile organic compounds (VOCs), oxides of nitrogen (NOx), sulfur dioxide (SO2), carbon monoxide (CO), and hydrogen chloride (HCI) were evaluated during the permit review process.

A public comment period has been established to allow citizens the opportunity to express any concerns or comments they may have about this permitting action. The public comment period is to begin on January 24, 2008 and end on February 25, 2008. A public hearing is scheduled by the Kansas Department of Health and Environment (KDHE) at the Goodland City - Commission Room, 204 West 11th Street, Goodland, Kansas 67735, on February 26, 2008 starting at 7:00PM (Mountain Time) to receive comments on the proposed issuance of the draft air quality construction permit.
