## County accepts bids for fairgrounds projects

ntbetz@nwkansas.com Sherman County commissioners accepted bids for replacing tile in the 4-H building and replacing a section of the fence between the carnival area and the arena and grandstand area.

Steve Duell, fair board member, met with the commissioners at their meeting last Thursday and presented bids on replacing the tile floor in the 4-H building.

Commissioner Kevin Rasure said he would excuse himself from the discussion because of a conflict of interest and left the room.

The bids for the tile in the 4-H building were Wane's Carpet & Drapery, \$7,691; BobRohr, \$15,002; and Randy Raile, \$16,242.

Duell said because of the big difference in the bids he had double checked to make sure everyone was bidding the same things.

Commissioner Mitch Tiede made the motion to accept the low bid from Wane's Carpet & Drapery. Commissioner Chuck Thomas joined Tiede in voting in favor.

Duell had talked to the commissioners at a previous meeting about replacing the wooden fence between the carnival and parking areas and the racetrack and arena. He had suggested putting up a metal pipe fence, and replacing the fence a section at a time.

Duell presented four bids for replacing the south section of the fence from the grandstand to the south end of the carnival area.

Those bidding included Goodys (Mike Yarger), \$4,350; Miller Construction, \$4,318; Malsom Enterprises, \$5,375; and Rasure Lumber Do It Center, \$12,578.

Tiede made a motion to accept the bid from Miller Construction and it passed 2-0 with Thomas voting in favor.

Rasure returned to the meeting. Duell said he is trying to get prices on other materials for fairgrounds
