Fingerprint ends nationwide '20s manhunt



The FBI credits the Fleagle case as the first time a single fingerprint was used to identify and convict criminals. The Fleagle Gang robbed banks in Larned, Kinsley, Marysville, Ottawa and McPherson Kan., Lamar, Colo., Eugene, Ore., and countless others of over \$1 million in the 10 years they operated.
