PUBLIC NOTICE

The Goodland Energy Resources LLC has filed an application with the USDA - Rural Development (RD) for financial assistance to develop a cogeneration plant that will produce steam and electricity for sale and will use coal and other biomass (tire chips, wood, and wood waste) as fuel for the plant. The specific elements of the proposed action are: The project is located 5 miles West of Goodland, KS and 1.5 miles north of I-70 located in section 20-8-40 Sherman County, KS.

1. 10 acres in 20-8-40 Sherman County, KS, known as Lot 6 of the Goodland Energy Center subdivision.

2. 10 acres of important farmland.

3. The plant will install advanced technology and emissions monitoring systems to mitigate and control the emissions from the plant. The air emissions are regulated in accordance with the Air Emission Source Construction Permit which the Company has received from the Kansas Department of Health and Environment. This permit limits the amount of emissions and outlines the mitigation procedures in place. In addition to the air emissions monitoring equipment, the plant will include water treatment facilities and will reuse water resources that would normally be discharged for the cooling systems of the plant. This process will mitigate the amount of water resources that are consumed within the plant.

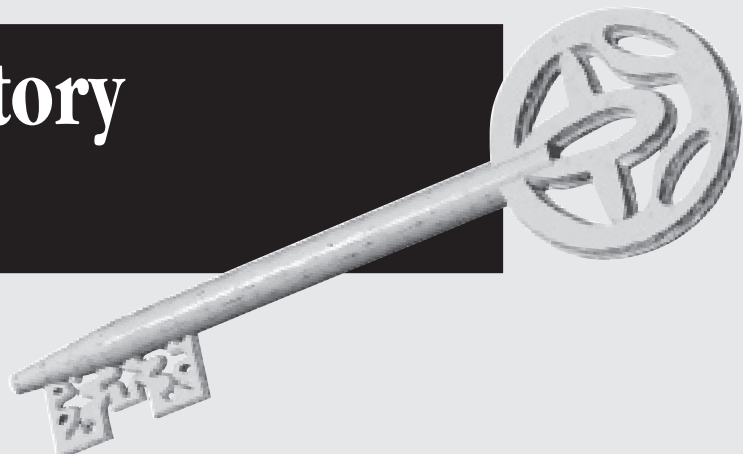
