Round head borers can be problem for lilacs, ashes

If you have had problems with the canes or stems of lilac and privet suddenly wilting, or ash trees that show borer holes in the trunk and larger branches, the ash/lilac borer may be to blame.

This insect causes the base of infested Lilac stems to swell and the bark to separate from the wood. A fine sawdust-like material is present around holes in the canes. Ash and mountain ash also are affected.

Spray treatments are started seven to 10 days after the capture of the first moths.

Sprays can also be timed using phenology, the practice of timing one event by another. The first spray should be applied when the Vanhoutte spirea is in full to late bloom, about the first full week of May.

A second spray should be applied four weeks after the first. Thoroughly treat the trunk and larger limbs of

Heavily infested Ash should be cut and burned during the fall and winter. Infested stems of Lilac or Privet should be removed as well. Permethrin (Hi-Yield Garden, Pet, and Livestock Insect Control) is labeled for control.

Though there are a number of other homeowner products that contain Permethrin, the product listed above is the only one Ward Upham,




