# Governor declares western Kansas a disaster

Gov. Kathleen Sebelius signed fourth is being investigated. a disaster emergency declaration Wednesday for 62 counties in western Kansas struck by the thunderstorms, hail, lightning, tornadoes, high winds and flooding last week which killed at least three people.

# Council tries to fill vacancy

The Sherman County Economic Development Council is seeking nominations from people who would like to fill a vacancy, and will consider the names at the meeting on Tuesday, June 17.

The vacancy developed when Darwin McClung resigned as interim director and moved to Wichita. McClung was council vice-chairman, and Thursday the council voted to name Steve West of Western State Bank to fill that slot.

The council meeting was rescheduled from Tuesday to Thursday at Western State.

The council met in closed session for 20 minutes at the end of the meeting to discuss personnel matters and continuing efforts to select a new executive director. The council has been without a director since Jeremy Jennings resigned in February.

The council met in closed session with Helen Dobbs, who is managing the office. Chuck Wilkens, council chairman, said no action was taken afterward.

In the absence of a director, Dobbs reported on activity for the past month. She said the county microloan balance has increased to \$8,384, and that most of the loans are current.

She said beginning next month, any of the loans that are in arrears will be notified by letter that if they do not contact the office to make arrangements they will be approached by the county attorney.

In other activity, she reported • The council books had been

audited and were in order. • The Work Center has a new computer assessment program to offer to those looking for a job. She said the program can help a person find

out what their interests are and what

jobs they may be best suited for. • The office had responded to two inquiries from the State Department of Commerce, contacting real estate agents and owners of properties fitting the requests.

• Asked for permission to buy an external hard drive to backup the data on the office computer. Two bids were taken from S&T Communications and Computer Solutions. Computer Solution for \$107. Don Newell, of S&T abstained from Newell abstaining.

Newell said the marketing committee had met that morning, and agreed the council needed to decide if they wanted to buy the ad. Wilkens said the guide will go to press the end of the month, and that last year 17,000 were printed and most have been handed out. Newell made the motion to approve the ad, and it passed unanimously.

• Brought up a project being proposed through The Hays Daily News in partnership with The Goodland Star-News to have people in Sherman County select the 8 Wonders of Sherman County. Newell said he felt it was more of a Convention and Visitors Bureau project. West said he felt it would be good if the two split the project. Wilkens said he would talk to Donna Price, executive director of the visitors bureau, and bring the information back to the council at the June meeting.

 Dobbs said she has been working with the Small Business Development Center from Hays, and helped with a sixth-grade program at the technical college.

 Suggested the council consider taking the \$10,000 earmarked for beautification and put it in a special account with the Sherman County Community Foundation until the Shine On Sherman County beautification committee can develop a plan and raise the matching money. The council decided to look at this and find out if the money could be recaptured if the committee fails to do anything.
